**(a): The State-wise performance details of houses sanctioned and constructed under Pradhan Mantri Awaas Yojana- Gramin (PMAY-G) in the country during each of the last five years i.e. from financial year 2018-19 to 2022-23 is given in Annexure.**

**(b): The Ministry has taken several initiatives to ensure timely completion of the houses under PMAY-G, inter alia, conferring awards to the best performing States/UTs, performance index dashboard, thereby creating healthy competition and motivation among the States/UTs for achieving the set targets. For overall implementation of PMAY-G, the Uttar Pradesh State had been given National Award in 2018 & 2019 by the Ministry of Rural Development.**

**(c): A total amount of Rs.2,20,666.70 crore has been released by the Central Government to the States/UTs under PMAY-G as on 20.07.2023. The State-wise details of number of houses constructed during each of the last five years is given in Annexure.**
