(a) & (b) All works under Pradhan Mantri Gram Sadak Yojana (PMGSY-I, II & III) in the State of Madhya Pradesh, including in Gwalior and Shivpuri districts, have been sanctioned as per the proposals received from the State and the allocation/ scheme norms.

The release of funds to the State for implementation of PMGSY is done on the basis of the proposal received from the State and depends, inter-alia, on works in hand, execution capacity of the State and unspent funds available with the State, and fulfilling of certain conditions laid down as per the programme guidelines.
