### FUNDS FOR ICDS TRAINING PROGRAMME

\*192. ADV. A.M. ARIFF:

Will the Minister of WOMEN AND CHILD DEVELOPMENT be pleased to state:

- (a) whether the Government has stopped training programmes for Integrated Child Development Services (ICDS) functionaries across the country, if so, the details thereof and the reasons thereof:
- (b) whether an amount of Rs. 251.11 lakhs is pending to the State of Kerala as central share of training expenses for ICDS functionaries for the FYs 2017-18, 2018-19 and 2019-20, if so, the reasons therefor;
- (c) whether the Government is in receipt of the Utilization Certificate of the above said training expenses for the said years; and
- (d) if so, whether the Government proposed to expedite the release of central share towards above said training expenses without further delay, if not, the reason therefor?

# Statement referred to in reply to Part (a) to (e) of Lok Sabha Starred Question No. 192 to be answered on 15.12.2023 regarding "FUNDS FOR ICDS TRAINING PROGRAMME"

(a) The components of Supplementary Nutrition under Anganwadi Services, Scheme for Adolescent Girls (SAG) and Poshan Abhiyaan have been aligned under Saksham Anganwadi and Poshan 2.0 as integrated nutrition support programme from the FY 2021-22. As per Saksham Anganwadi & Poshan 2.0 Guidelines, to strengthen Anganwadi Services and to achieve their intended outcomes, it is vital to build the capacity and confidence of frontline functionaries. Mission Poshan 2.0 has capacity building of frontline functionaries as one its key pillars for effective delivery and outcome achievement.

The Frontline workers in the Anganwadi ecosystem comprise of 3 tiers, viz. Lady Supervisors, Anganwadi workers and Anganwadi Helpers. The areas of capacity building for training to these frontline workers are given as under:-

- i. Training on technical knowledge, comprising of topics like ante and post natal care practices, infant and young child care and feeding practices, growth monitoring, supplementary nutrition, Regional meal plans, poshan vatikas, poshan tracker, pre-school education and convergence etc.
- ii. Training on soft skill based knowledge, comprising of topics like organising effective home visits, community based events and Jan Andolans, techniques for effective behaviour change communication, planning and time management etc.

To carry out such training, the States identify State and District level Institutes for training of field functionaries. Training to Anganwadi functionaries is imparted at Government run Anganwadi Training Centres (AWTCs)/Middle level Training Centres (MLTCs) or at National Institute of Public Cooperation & Child Development (NIPCCD).

Further, Ministry has drafted a training schedule, involving a cascading model of training, wherein Master Trainers (namely, District Officers, Block Coordinators and Supervisors) are trained through NIPCCD, and the master trainers directly train all Anganwadi Workers in the field.

Further, NeGD is regularly conducting field level trainings/workshops directly for Anganwadi Workers regarding use of the Poshan Tracker Application. Multiple rounds of trainings have been held both virtually and physically, in various districts across the country.

(b) to (d): With respect to Kerala, for the period 2017-18 to 2019-20, an amount of Rs. 90.20 lakhs was released to the State of Kerala as an ad-hoc grant for the year 2018-19, as a one time grant released to all States/UTs since the Utilization Certificates/Statements of Expenditure were pending for the previous financial years.
