Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) the details of various Rural Development Schemes being implemented across the country including Punjab;
- (b) the details of funds sanctioned and allocated for each of these schemes within Punjab during the last year and current year;
- (c) whether the Government is aware about the non-release of Rural Development Fund (RDF) to Punjab and if so, the reasons therefor;
- (d) the amount of RDF due for Punjab along with the time by which the Government will release the withheld RDF to Punjab; and
- (e) the steps taken by the Government to increase the RDF for Punjab along with the time by which it is likely to be increased?

STATEMENT REFERRED TO IN REPLY TO PART (a) TO (e) OF THE LOK SABHA STARRED QUESTION NO. 239 FOR REPLY ON 19.12.2023

- (a): Department of Rural Development (DoRD), Ministry of Rural Development (MoRD) is implementing a number of schemes all over the rural areas of the country, including Punjab, namely Mahatma Gandhi National Rural Employment Guarantee Scheme (Mahatma Gandhi NREGS), Pradhan Mantri Awaas Yojana- Gramin (PMAY-G), Pradhan Mantri Gram Sadak Yojana (PMGSY), Deendayal Antyodaya Yojana – National Rural Livelihoods Mission (DAY-NRLM), Deen Dayal Upadhayay - Gramin Kaushalya Yojana (DDU-GKY), Rural Self **Employment Training Institutes (RSETIs), National Social Assistance** Programme (NSAP) and Shyama Prasad Mukherji Rurban Mission (SPMRM). However, Shyama Prasad Mukherji Rurban (SPMRM), which was launched in February, 2016, has been discontinued from 31st March, 2022. Further, Department of Land (DoLR), **MoRD** is also implementing **Development Component (WDC) of Pradhan Mantri Krishi Sinchayee** Yojana (PMKSY) with primary objective to develop rainfed/ degraded lands.
- (b): The details of funds sanctioned and allocated for each of these schemes within Punjab during the last year and current year are at Annexure.
- (c) to (e): So far as non-release of Rural Development Fund (RDF) is concerned, Ministry of Consumer Affairs, Food and Public Distribution has informed that the matter is currently sub-judice in the Hon'ble Supreme court of India. So far as this Ministry is concerned, release of funds for rural development is a continuous process. Funds are released taking into account the balance of funds available with the States, submission of requisite documents / utilization certificate as per schematic requirements, ensuring proper utilization of funds already allocated under the schemes, ensuring strict adherence of the schematic guidelines and assessing the actual requirement at the ground level. This Ministry remains constantly in touch with the State Governments for effective implementation schemes/programmes of Rural Development and increases the allocation to States, including Punjab, wherever feasible.
