Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) whether any work is being carried out under the Shyama Prasad Mukherji Rurban Mission (SPMRM) in the country particularly in Shahjahanpur Parliamentary Constituency of Uttar Pradesh;**
- (b) if so, the details of such works carried out along with the latest status thereof particularly in the said Constituency of Uttar Pradesh; and**
- (c) the details of the Central funds allocated and utilized under the Mission during each of the last three years and the current year, State-wise?**

(a)&(b) Under Shyama Prasad Mukherji Rurban Mission, 300 clusters were allocated to different States/Union Territories across the country. However, no cluster has been allocated to the Shahjahanpur Parliamentary Constituency of Uttar Pradesh.

(c) Under SPMRM, the funds are not allocated but are released to the States/Union Territories based on their requirements and the utilization of funds. 31st March 2022 has been declared as the sunset date for the scheme and the funds for the ongoing works were released till 31st March 2023. No fund has been released in the current financial year. The details of Central funds released to the States/UT in the last three years is given at Annexure 1. The details of funds utilised in the last 3 years and current year (including the State share) is given at Annexure 2.
