**(a): The details of loans disbursed to the street vendors under Pradhan Mantri Street Vendor's AtmaNirbharNidhi (PM SVANidhi) Scheme in Karakat, Singhbum, Amravati, Sonipat, Sheohar (Bihar), Bhagalpur and Jammu Parliamentary Constituencies during the last three years are at Annexure-I.**

**(b): Yes Sir. As on 29 November 2023, there are 56.24 lakh street vendor beneficiaries to whom loans amounting to ₹ 9,723 crore have been disbursed under Pradhan Mantri Street Vendor's AtamNirbhaNidhi (PM SVANidhi) Scheme since inception of the scheme.**
