#### NEW PROJECTS UNDER PMKSY

- (a) whether the Government has approved the inclusion of new projects under the Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) Accelerated Irrigation Benefit Programme (AIBP) which envisages the construction of new water reservoirs at villages across various rivers including in Andhra Pradesh and Telangana;
- (b) if so, the details thereof State-wise along with the present status of implementation and the funds sanctioned under such identified projects; and
- (c) the manner in which it has benefited the farmers till now and the future action plan thereof along with funds spent, State-wise?

# STATEMENT REFERRED TO IN REPLY TO PARTS (a) TO (c) OF STARRED QUESTION NO. \*64 TO BE ANSWERED ON 07.12.2023 IN LOK SABHA REGARDING "NEW PROJECTS UNDER PMKSY"

(a) to (c) Yes Sirs. PradhanMantriKrishiSinchayeeYojana (PMKSY) was launched during the year 2015-16, with an aim to enhance physical access of water on farm and expand cultivable area under assured irrigation, improve on-farm water use efficiency, introduce sustainable water conservation practices, etc. Accelerated Irrigation Benefit Programme (AIBP) is one of the components of PMKSY.

At the inception of AIBP under PMKSY in 2016, financial assistance under the scheme was restricted to the identified 99 priority major and medium irrigation projects and 7 phases. However, while approving continuation of PMKSY-AIBP for the period 2021-2026, provision for inclusion of other major, medium irrigation projects under PMKSY-AIBP, including extension-renovation-modernization (ERM) projects, has also been approved.

The eligibility criteria for inclusion under the PMKSY-AIBP, inter-alia, require the projects to have investment clearance by this Ministry. Further, the project should also be in advanced stage of construction, having at least 50% overall physical progress, except for either extension- renovation-modernization projects, or projects having command in certain special category areas. The detailed eligibility criteria and procedure required to be followed for inclusion of such additional projects, including those on rivers in Andhra Pradesh and Telangana, have been laid down in detail in the guidelines of PMKSY-AIBP which is available at the website of the Ministry.

Out of the 99 priority projects (and seven phases) taken up under PMKSY-AIBP in 2016, 54 projects have been reported complete so far. Out of balance priority projects, 21 projects have progress of more than 90% and 13 projects have progress between 80 to 90%. Under these projects, 25.11 lakh hectare additional irrigation potential has been created during 2016-17 to 2022-23. State wise details of status of these projects, fund sanctioned, and irrigation potential created through these projects, including projects of Andhra Pradesh and Telangana, are placed at **Annexure-I**.

Further, 8 new major/ medium and ERM projects have been included under PMKSY-AIBP subsequent to the approval of continuation of PMKSY-AIBP for the period 2021-2026. Statewise details of status of these projects, fund sanctioned and irrigation potential created through these projects, are placed at **Annexure-II**.
