(a) to (c) The details of the All India Institute of Medical Sciences (AIIMS) projects sanctioned during the last nine years (2015-2023) under Pradhan Mantri Swasthya Suraksha Yojana (PMSSY), along with stages of completion is at Annexure.

As per loan agreement signed with Japan International Cooperation Agency (JICA), the targeted date of completion of AIIMS Madurai is October 2026.
