HEALTH PROJECTS IN MADHYA PRADESH

1029. SHRIMATI SANDHYA RAY:

Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) the number of Central Schemes being implemented/run by the Ministry of Health and Family Welfare in the State of Madhya Pradesh especially in Bhind and Datia districts;
- (b) the total amount spent on these schemes since last 5 years; and
- (c) the details of the ongoing Health Projects in Madhya Pradesh especially in Bhind and Datia districts?

(a) to (c): The various schemes implemented under National Health Mission (NHM) by Government of India in various states including Madhya Pradesh are operationalisation of Ayushman Arogya Mandirs (erstwhile Ayushman Bharat Health and Wellness Centres) by transforming the existing Sub Centres and Primary Health Centres support for engaging of health human resource on contractual basis, National Ambulance Services, Mobile Medical Units, ASHAs, Infrastructure strengthening, 24 x 7 Services and First Referral facilities, Mera Aspataal, Kayakalp Award Scheme, Prime Minister's National Dialysis Programme, National Quality Assurance Standards implementation and related Activities, LaQshya Certification, Biomedical Equipment Maintenance and Management Programme, Free Diagnostics Service Initiative and Free Drugs Service Initiative. Further, initiatives such as Mission Parivar Vikas, Adolescent Friendly Health Clinics (AFHCs), Weekly Iron Folic Acid Supplementation (WIFS), Menstrual Hygiene Scheme, Facility Based Newborn Care (FBNC), Home Based Newborn Care Program, Social Awareness and Actions to Neutralize Pneumonia Successfully (SAANS), Home Based Care for Young Child (HBYC), Rashtriya Bal Swasthya Karyakram (RBSK), Rashtriya Kishor Swasthya Karyakram (RKSK), Early Childhood Development (ECD), Comprehensive Abortion Care (CAC), Anemia Mukht Bharat

(AMB) strategy, Pradhan Mantri TB Mukh Bharat Abhiyaan (PMTBMBA), Nutrition Rehabilitation Centre (NRC) program and Universal Immunization programme.

Pradhan Mantri Ayushman Bharat Health Infrastructure Mission (PM-ABHIM), a Centrally Sponsored Scheme (CSS), includes support for infrastructure development for Sub-Health Centres, Urban Health and Wellness Centres, Block Public Health Units, Integrated District Public Health Laboratories and Critical Care Hospital Blocks.

India COVID-19 Emergency Response & Health System Preparedness Package (ECRP-I & II package), a Central Sector Scheme, was launched in 2020 under NHM for providing support to Primary, Secondary and Tertiary care facilities for management of the COVID-19 pandemic and any future outbreaks in India. Under ECRP-II, support is provided for Pediatric Care Units, Pediatric Centre of Excellence, Augmentation of additional beds by provision of Prefab Units, Augmentation of ICU beds in public healthcare facilities, 50 & 100 bedded Field Hospitals, Referral Transport & Liquid Medical Oxygen Plant with medical gas pipeline system.

Further, under Fifteenth Finance Commission, total funds released to the State of Madhya Pradesh is Rs. 1808.43 cr. for the year 2021-22 and 2022-23 to strengthen the healthcare system in state.

Total amount released under these schemes in Madhya Pradesh since last 5 years is attached at **Annexure**.

Further, an amount of Rs. 2375.00 lakhs has been approved for FY 2021-22 for Critical Care Block (CCB) at 50 bedded Government Medical College, Datia District and an amount of Rs. 125 lakhs each for Bhind and Datia Districts has been approved for FY 2023-24 for Integrated Public Health Laboratories (IPHL).
