**Treatment of Fatal Disease**

†1068. SHRI ANIL FIROJIYA:

Will the Minister of AYUSH be pleased to state:

- (a) whether the Government has taken any measures for the treatment of fatal diseases like Hepatitis-B and if so, the details thereof;
- (b) whether the treatment of Hepatitis-B is possible in India;
- (c) if so, the details thereof along with the method of treatment; and
- (d) the names of complex and fatal diseases of which treatment is possible through AYUSH?

**ANSWER**

(a) to (c) The Disease Hepatitis-B as such is not mentioned in the ancient literatures of Ayurveda, Unani, Siddha and Homoeopathy. However, the condition is manageable through these systems of medicine. In Ayurveda, Hepatitis B is considered under *YakritaVikar* and its management is based on individualised approach as per the *dosh dushyasammurchhana* of the disease. In Unani system of medicine, the Hepatitis B has not been described as such, but a similar condition like *Waram-al-Kabid* is mentioned in ancient literatures. Many *Mufradat* (single) and *Murakkabat* (Compound) drugs preparations have been documented in the treatment of *Waram al-Kabid*. Similarly, Hepatitis-B unless requires intensive treatment in critical care, is manageable with Homoeopathy and Siddha system of medicine on symptomatic basis. Management of Hepatitis-B is available through OPDs in all National Institutes and Research Councils of Ayurveda, Unani, Siddha and Homoeopathy. The list of National Institutes working under Ministry of Ayush is annexed as Annexure I.

(d) The treatment modalities through Ayush systems of medicine provides comprehensive treatment for many diseases including complex and chronic cases. Most of the chronic cases especially Non-Communicable and lifestyle related diseases are easily manageable though principles and practices of Ayush treatment modalities.
