# LOK SABHA UNSTARRED QUESTION NO. 111 ANSWERED ON DECEMBER 4th, 2023/ AGRAHAYANA 13, 1945 (SAKA) PRADHAN MANTRI MUDRA YOJANA (PMMY)

### 111. SHRI RAJENDRA AGRAWAL: SHRI ARUN KUMAR SAGAR:

Will the Minister of FINANCE be pleased to state:

- (a) whether the nationalized banks have organized the programmes related to centrally operated schemes like Pradhan Mantri Mudra Yojana, Stand Up India Yojana, Pradhan Mantri Jeevan Jyoti Bima Yojana (PMJJBY), Pradhan Mantri Suraksha Bima Yojana (PMSBY), Atal Pension Yojana etc., in Meerut and Shahjahanpur Constituencies of Uttar Pradesh;
- (b) if so, the place-wise/date-wise details of the programmes organized in Meerut Constituency during the last three years;
- (c) whether the nationalized banks have invited the local public representatives in each programme organized in Meerut Constituency during the above period;
- (d) if so, the details thereof;
- (e) if not, the reasons therefor; and
- (f) the steps taken by the Government to ensure participation of local representatives in the programmes related to the operation of central schemes by the nationalized banks?

#### **ANSWER**

### MINISTER OF STATE IN THE MINISTRY OF FINANCE (Dr. BHAGWAT KARAD)

- (a) Banks have organised various programmes in Meerut and Shahjahanpur constituencies of Uttar Pradesh in collaboration with the local administration and other stake holders for Schemes like Pradhan Mantri Mudra Yojana (PMMY), Stand Up India Yojana (SUPI), Pradhan Mantri Jeevan Jyoti Bima Yojana (PMJJBY), Pradhan Mantri Suraksha Bima Yojana (PMSBY) and Atal Pension Yojana (APY) etc.
- (b) to (f) State Level Bankers' Committee (SLBC), Uttar Pradesh (UP) has informed that invitations are sent to the various categories of public representatives while organising programmes under these Schemes.

Details of the programmes organised wherein the public representatives participated in the Meerut Constituency during the last three years is placed at Annexure I.

Further, Department of Financial Services has also written to SLBC, UP to ensure the presence of Public Representatives viz. MPs/MLAs etc. in the meetings of the District Level Review Committees (DLRCs) and also in all the Credit Outreach programmes under various Government Schemes.
