**REVAMPED BONDED LABOUR REHABILITATION SCHEME IN HARYANA**

**120. SHRIMATI SUNITA DUGGAL:**

**Will the Minister of LABOUR AND EMPLOYMENT be pleased to state:**

- (a) the details of funds released under the revamped Bonded Labour Rehabilitation Scheme, if so, the details thereof, State/UT-wise including the State of Haryana;**
- (b) the number of beneficiaries under the scheme including Haryana and the amount transferred under Direct Benefit Transfer (DBT); and**
- (c) the details and the number of proposals received from State Governments for immediate cash assistance and rehabilitation assistance under the scheme, State-wise including Haryana?**

**ANSWER**

(SHRI RAMESWAR TELI)**

**(a) to (c): The Ministry of Labour & Employment has been implementing a Central Sector Scheme viz. Rehabilitation of Bonded Labourer for identification and rehabilitation of bonded labourers. This scheme is a demand driven scheme where the rehabilitation assistance amount is provided by the respective State/Union Territories to the rescued bonded labourers which are reimbursed by Central Government on receipt of proposal from them.**

**Under the Scheme, rehabilitation assistance to the tune of Rs. 1.00 lakh, Rs. 2.00 lakh and Rs. 3.00 lakh are provided to each rescued bonded labourers by the concerned State/UT Government through Direct Benefit Transferred (DBT) based on their category and level of exploitation. The details of number of bonded labourers rehabilitated and details of rehabilitation amount released during 2020-21 to 2023-24, State-wise, (upto 31.10.2023) is annexed.**

**During the last 3 years, no proposal for reimbursement of immediate cash assistance or rehabilitation assistance has been received from the State Government of Haryana.**
