Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:

(a) the number of candidates registered under the Capacity Building and Entrepreneurship Development Program on E-waste management and Skill City Programme State-wise including North Eastern (NE) States during the FY 2021-22 and FY 2022-23;

(b) the number of candidates in each category belonging to Scheduled Castes and Other Backward Classes having annual family income below Rs. 3.00 lakh and Economically Backward Classes having annual family income below Rs. 1.00 lakh; and

(c) the details of de-notified, Nomadic and Semi-Nomadic Tribes and Safai Karamcharis including his/her dependents in the NE states in the FY- 2021-22 and FY 2022-23.

(a) Under the Govt. of India's Skill India Mission (SIM), the Ministry of Skill Development and Entrepreneurship (MSDE) delivers skill, re-skill and up-skill training through an extensive network of skill development centres/colleges/institutes etc. under various schemes, viz. Pradhan Mantri Kaushal Vikas Yojana (PMKVY), Jan Sikhshan Sansthan (JSS), National Apprenticeship Promotion Scheme (NAPS) and Craftsman Training Scheme (CTS) through Industrial Training Institutes (ITIs), to all the sections of the society across the country. The SIM aims at enabling youth of India to get future ready & industry ready skills.

The Ministry of Electronics & Information Technology implemented a Capacity Building and Entrepreneurship Development Programme on E-waste Management and Skill Development programme for eight North East States through National Institute of Electronics & Information Technology (NIELIT), Gangtok. The details of trainings under this programme is given in the table below:
