RESTORATION OF OLD TEMPLES AND MONASTERIES

†1349. SHRI R.K. SINGH PATEL:

Will the Minister of CULTURE be pleased to state:

- (a) whether the Government proposes to restore the old temples and monasteries of public importance located in the country including those in Chitrakoot and Banda region of Uttar Pradesh;
- (b) if so, the details thereof;
- (c) whether the Government proposes to formulate any plan to develop small tourist destinations in the country; and
- (d) if so, the details thereof?

ANSWER

MINISTER OF CULTURE, TOURISM AND DEVELOPMENT OF NORTH EASTERN REGION (SHRI G. KISHAN REDDY)

- (a) There are 3697 ancient monuments and archaeological sites and remains of national
- & importance under care and maintenance of Archaeological Survey of India (ASI) in the
- (b) country. Conservation and restoration of these monuments and sites including ancient temples and monasteries is a regular process and is taken up as per the requirement and availability of resources.

Conservation of (i) Priest house at Ramnagar, Karvi, (ii) Stone temple, Ganesh bagh at Karvi and (iii) Temple in centre of tank at Karvi in Chitrakoot District have been undertaken by ASI.

- (c) Ministry of Tourism has launched a scheme called Swadesh Darshan 2.0 (SD2.0) with the
- & objective to develop sustainable and responsible tourism destinations. As per the SD2.0
- (d) scheme guidelines, the State Governments/UT Administrations prepare a State Perspective Plan (SPP) analysing tourism potential of various destinations based on the features like major tourism attractions, offerings, connectivity, current tourism eco system, state support etc. Accordingly, the Ministry of Tourism in consultation with the respective State Government/UT Administration selects destinations for development. The Ministry of Tourism has notified 55 destinations in the country for development under the scheme, the list of which is attached in Annexure-I.
