Will the Minister of PANCHAYATI RAJ be pleased to state:

- (a) the details of the various programmes undertaken by the Ministry to promote digitisation of panchayats in the country;
- (b) the objectives of the Ministry in promoting digitisation;
- (c) the progress made so far in the digitisation of panchayats, State and district-wise including Jharkhand; and
- (d) the total funds allocated to enhance the working standards of panchayats in the country, State-wise including Rajasthan?

ANSWER

THE MINISTER OF STATE FOR PANCHAYATI RAJ

(a) to (c) Under Digital India Programme, Ministry is implementing e-Panchayat Mission Mode Project (MMP) with the aim to making Panchayati Raj Institutions (PRIs), more transparent, accountable, and effective as local self-governments. Building on the achievements in the past, the Ministry launched eGramSwaraj, a work-based comprehensive application for PRIs under the e-Panchayat MMP on 24th April 2020. This application encompasses all aspects of Panchayat functioning viz. planning, budgeting, accounting, monitoring, asset management etc., on a single digital platform including online payments. So far, 2.49 lakh GPs have prepared and uploaded

their Gram Panchayat Development Plans (GPDPs) for 2023-24. Further, 2.32 lakh Gram Panchayats have completed online transactions for 15th Finance Commission grants for 2023-24. State wise adoption of eGramSwaraj including Jharkhand is given at **Annexure-I**.

Also, for strengthening the transparency and accountability at grassroots level; the Ministry has rolled out an application - AuditOnline under e-panchayat Mission Mode Project (MMP). It allows for online audit of Panchayat accounts and records detailed information about internal and external audit. For audit year 2021-22, 2.47 lakh Audit Plans have been created and 2.37 lakh Audit Report have been generated. Similarly, For audit year 2022-23, 1.44 lakh Audit Plans have been created and audit reports have been generated for 29,981 Gram Panchayats.

For attaining the vision of Digital India, BharatNet project is being implemented by Department of Telecommunications in a phased manner to create network to connect all the GPs by broadband in the country. So far, 2,10,181 GPs have been made Service Ready under the BharatNet project in the country. The scope of BharatNet on 30.06.2021 has been extended up to all inhabited villages beyond GPs in the country. The State/UT-wise details of Service Ready Gram panchayats is given at **Annexure-II**.

(d) Panchayat being a State subject, providing infrastructural facilities to GPs is primarily the responsibility of States. Under the e-Panchayat MMP, no direct financial assistance is provided to States / UTs for implementation of e-governance in the Panchayats. However, the Centrally Sponsored Scheme of revamped Rashtriya Gram Swaraj Abhiyan (RGSA) being implemented from 01.04.2022 to 31.03.2026, supplements the efforts of States on a limited scale by providing financial support for infrastructural facilities for GPs such as Gram Panchayat Bhawans, computers and peripherals. The State wise fund released including Rajasthan, during current financial year (2023-24) is given at **Annexure-III**.
