#### Will the Minister of YOUTH AFFAIRS AND SPORTS be pleased to state:

- (a) the total number of sportspersons in the country and the percentage of sportspersons who have benefitted from the Khelo India Scheme and other such Central schemes;
- (b) the details of sportspersons who have been provided financial assistance/ scholarship under Khelo India Scheme during the last five years and the current year, State/ UT and year-wise;
- (c) the details of the funds allocated during the said period, State/ UT-wise; and
- (d) the time-frame fixed and the present status for targetted sports infrastructure development under the said scheme during the said period, State and UT-wise?

- (a) 'Sports' being a State subject, the responsibility to promote sports rests primarily with the respective State/Union Territory Governments. The Union Government supplements their efforts. 2752 and 8639 sportspersons have been supported under the Khelo India Scheme and other Central Sports Promotional Schemes respectively.
- (b) The number of sportspersons who have been provided financial support/scholarships under the Khelo India Scheme during the last five years is given below:-
