MGNREGS**

1456. ADV. A.M. ARIFF:

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) the number and percentage of households who have been provided with at least 100 days of employment in a year under Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) from Financial Years 2018-19 to 2023-24 till date, State and UT-wise;**
- (b) whether it is true that the proportion of households with at least 100 days of employment under MGNREGS reduced from Financial Years 2021-22 to 2022-23;**
- (c) if so, the details thereof and the reasons therefor;**
- (d) whether it is true that the Government proposes to restrict the provision of employment under MGNREGS to only priority (erstwhile BPL) households in the country, if so, the details thereof and the reasons therefor; and**
- (e) whether the Government proposes to widen the scope of the activities to be undertaken under MGNREGS and if so, the details thereof?**

(a): State/UT-wise details of households availed employment, households completed 100 days of employment and percentage of households who have completed the 100 days of employment under Mahatma Gandhi National Rural Employment Guarantee Scheme (Mahatma Gandhi NREGS) from financial years 2018-19 to 2023-24 (as on 06.12.2023) is given at Annexure.

(b)&(c): Details of households availed employment, households completed 100 days of employment and percentage of households who have been completed the 100 days of employment under Mahatma Gandhi NREGS in the financial year 2021- 22 to 2022-23 is given below:

Mahatma Gandhi NREGS is a demand driven wage employment Scheme. It provides livelihood security, i.e. fall back options for livelihood for the rural households, when no better employment opportunity is available.

(e): As per Section 29 of the Act, Central Government may add new works to the permissible list of works under Schedule 1 of the Act. Adding new works under Schedule 1 of the Act is a regular exercise and new works are added on the basis of merit in alignment with the focus and objectives of the Act. Accordingly, there are 266 permissible works under Mahatma Gandhi NREGA. Some of the recently added works to the list of permissible works under Mahatma Gandhi NREGA are given below:

- (i) Construction of biogas plant for individual;**
- (ii) Unskilled wage component towards the construction of bio-gas plant for community;**
- (iii) Maintenance of tunnel constructed by Border Road Organisation (BRO);**
- (iv) Maintenance of bridges constructed by Border Road Organisation (BRO); and**
- (v) Construction of Liquid Waste Chamber for individuals**
