Will the Minister of FOOD PROCESSING INDUSTRIES be pleased to state:

- (a) whether the Government has prepared any long term scheme for the processing of agricultural products in the rural areas;
- (b) if so, the details thereof;
- (c) whether the Government has prepared any action plan to create employment opportunities and to promote food processing in the rural areas;
- (d) if so, the details thereof, State-wise including Rajasthan; and
- (e) the amount of funds proposed to be spent by the Government in this regard State-wise, particularly in Maharashtra?

ANSWER

THE MINISTER OF FOOD PROCESSING INDUSTRIES (SHRI PASHUPATI KUMAR PARAS)

(a) to (e): In order to ensure overall development of Food Processing Industries including processing of agro- products, Ministry of Food Processing Industries (MoFPI) has been incentivizing setting up/expansion of related infrastructure through its Central Sector Umbrella Scheme Pradhan Mantri Kisan SAMPADA Yojana (PMKSY), Production Linked Incentive Scheme for Food Processing Industry (PLISFPI) and Centrally sponsored PM Formalization of Micro Food Processing Enterprises (PMFME) scheme across the country including rural areas and thereby creating off-farm employment opportunities in Food Processing Sector.

Under component schemes of PMKSY, MoFPI provides mostly credit linked financial assistance (capital subsidy) to entrepreneurs with total outlay of Rs 4600 Cr for 15th Finance Commission Cycle. PMKSY is not any region or state specific but demand driven and is implemented across the country. So far, Ministry has approved 41 Mega food Parks, 372 Cold Chain projects, 73 Agro- Processing Clusters, 513 Food Processing Units, 61 Creation of Backward & Forward Linkages Projects & 53 Operation Green projects across the country under corresponding component schemes of PMKSY. The estimation of employment opportunities created through projects completed under PMKSY is placed at **Annexure.**

Ministry provides financial, technical and business support for setting up/ upgradation of 2 lakh micro food processing enterprises under PMFME scheme. The scheme is operational for a period of five years from 2020-21 to 2024-25 with an outlay of Rs.10,000 Crore. A total of 62712 micro food processing enterprises have been approved in the country since 2020-21 under PMFME, out of which 10806 & 447 micro food processing units are located in Maharashtra & Rajasthan respectively.

PLISFPI is, inter alia, intended to support creation of global food manufacturing champions and support Indian brands of food products in international market. The Scheme is being implemented over a six-year period from 2021-22 to 2026-27 with an outlay of Rs. 10,900 crores. So far, a total of 2.36 Lakh employment opportunities are estimated through the scheme.
