Promotion of Pisciculture

†1483. SHRI NABA KUMAR SARANIA:

Will the Minister of **FISHERIES, ANIMAL HUSBANDRY AND DAIRYING**
मत्स्यपालन, पशुपालन और डेयरी मंत्री be pleased to state:

- (a) whether the Government has any proposal or scheme to promote pisciculture and the production of meat to cater to nearly 95 per cent non-vegetarian population of Assam and the North Eastern States and if so, the details thereof;
- (b) the details of Schemes formulated for the rearing animals and increasing milk production and reducing adulteration, State-wise including North Eastern States;
- (c) the number and details of entrepreneurs foraying this business under the milk scheme along with the kind of financial assistance provided by the Government to them during the last three years, State and district-wise; and
- (d) the details of various goat farms operating in the country, State and district-wise?

ANSWER

MINISTER OF FISHERIES, ANIMAL HUSBANDRY AND DAIRYING

(SHRI PARSHOTTAM RUPALA)

(a): To realize the potential of fisheries sector in the country, the Department of Fisheries, Ministry of Fisheries, Animal Husbandry and Dairying, Government of India has been taking up various initiatives for holistic development of fisheries and promotion of pisciculture in the country including North Eastern States. The initiatives inter-alia includes implementation of three major schemes namely (i) Centrally Sponsored Scheme(CSS) on Blue Revolution: Integrated Development and Management of Fisheries implemented during the period 2015-16 to 2019-20 with the central outlay of Rs.3000 crore and fisheries projects with an investment of Rs. 5000 crore were approved under this scheme during above said period, (ii) Pradhan Mantri Matsya SampadaYojana (PMMSY) implemented for a period of 5 years from year 2020-21 to 2024-25 with a total investment of Rs.20050 crore and projects worth of Rs 17527.22 crore with central share of Rs.7209.31 crore have been approved so far under this scheme and (iii) Fisheries and Aquaculture Infrastructure Development Fund (FIDF) implemented from the year 2018-19 with funds size of Rs.7522.48 crore to provide concessional finance to various end implementing agencies including State /UTs for creation of fisheries infrastructure facilities and fisheries infrastructure projects worth of Rs 5588.63 crore have been approved under this scheme.

Similarly, the Department of Animal Husbandry and Dairying, Ministry of Fisheries, Animal Husbandry and Dairying, Government of India is also implementing following schemes boost the meat production across the country including non-vegetarian population State of Assam and other North Eastern States, are (i) National Livestock Mission (NLM), (ii) Entrepreneurship Development and Employment Generation (EDEG), and (iii) Livestock Health and Disease Control (LHDC), etc.

(b): The schemes implemented by the Ministry of Fisheries, Animal Husbandry and Dairying, Government of India for the rearing animals and increasing milk production and reducing adulteration in the country including North Eastern States, such as (i) Rashtriya Gokul Mission(RGM), (ii) National Programme for Dairy Development (NPDD), (iii) Dairy Processing and Infrastructure Development Fund (DIDF), (iv) Supporting Dairy Cooperative and Farmer Producer Organizations (FPO) engaged in dairy activities, (v) Dairy Entrepreneurship Development Scheme (DEDS), (vi) Animal Husbandry Infrastructure Development Fund(AHIDF), etc.

(c): In order to support entrepreneurs, Department of Animal Husbandry and Dairying is promoting establishment of breed multiplication farm preferably of indigenous breeds on hub and spoke model under Rashtriya Gokul Mission scheme. Under this scheme, 50% capital subsidy is available for eligible entrepreneurs (individual/ SHGs/FCO/FPO/JLGs and section 8 companies). Entrepreneurs assisted for establishment of breed multiplication farm are also eligible for interest subvention under Animal Husbandry Infrastructure Development Fund. State wise and district wise details of the projects supported under the scheme during the last three years are given at Annexure-I.

(d): The state-wise details of various goat farms operating in the country are at Annexure-II.
