STATUS OF RCPLWEA

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) the status of implementation of Road Connectivity Project for Left Wing Extremism Affected Areas (RCPLWEA), Statewise;**
- (b) whether the Government is aware that the work has exceeded the initially allocated deadline and if so, the revised deadline and targets, if any; and**
- (c) the measures taken by the Government to ensure that States adhere to the revised deadline?**

(a) The State-wise details of implementation of Road Connectivity Project for Left Wing Extremism Affected Areas (RCPLWEA) is given at Annexure.

(b) The timeline for completion of RCPLWEA was March, 2023. However, based on the requests received from State Governments, the timeline has been extended to March 2024. States have been advised to complete all projects under RCPLWEA by March, 2024.

(c) This Ministry has taken a number of initiatives to ensure that States may able to complete all the sanctioned works within the prescribed time-line. The programme is regularly monitored by way of Regional Review Meetings (RRMs), Performance Review Committee (PRC) Meetings and Pre-Empowered/ Empowered Committee Meetings

with the States. In addition to this, special review meetings/ monthly review meetings are also held at the level of Secretary/ Additional Secretary/Joint Secretary, Ministry of Rural Development with Chief Secretaries/Additional Chief Secretaries/Principal Secretaries/ Chief Executive Officer - State Rural Roads Development Agencies (SRRDAs) of the States. Necessary hand-holding of the States is also conducted by means of trainings, seminar/conferences and Inter-departmental meetings etc. Further, implementation of all sanctioned works is also monitored through Online Management, Monitoring and Accounting System (OMMAS) on a real time basis to ensure that the physical and financial progress is in line with the overall targets given to States.
