LOW QUALITY OF MATERIAL USED IN ROADS

1567. SHRI SANTOSH PANDEY:

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) the total number of new roads and roads to be renovated, approved under the Pradhan Mantri Gram Sadak Yojana (PMGSY) from January 1st, 2020 to 31st December, 2022 in Kabirdham district falling under Rajnandgaon Parliamentary Constituency;
- (b) the details of roads name-wise and lengthwise, amount sanctioned and the name of the contractor firm;
- (c) the names of roads regarding which complaints of poor quality and corruption have been received by the Chief Engineer, Rural Development Agency, Raipur or the higher office and the points of the complaint; and
- (d) whether low quality asphalt and other material have been used in the roads from Silhati to Bhainsbod, Saliha to Bazar Charbhata, Singhari to Pandatarai Road to Mahali Bhalpahari, Pandatarai Bhalpahari to Achanakpur, Kapadah to Saraiset of Kabirdham district and payments have been made to the contractors without checking the quality of materials?
