PMGSY-III IN MAHARASHTRA

1569. SHRI SHRINIWAS PATIL:

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) the number of projects completed, pending and ongoing along with their latest status as on date under Pradhan Mantri Gram Sadak Yojana (PMGSYIII) in Maharashtra since 2019;**
- (b) the total funds allocated, released and utilized in this regard during the said period, district-wise particularly in Satara Parliamentary Constituency; and**
- (c) the number of roads which are yet to be sanctioned by the Union Government under the said yojana in Satara district of Maharashtra along with the number of roads completed till date?**

(a) The number of projects sanctioned and completed as on 06.12.2023 under Pradhan Mantri Gram Sadak Yojana -III (PMGSY-III) in Maharashtra since 2019 are as under:-

The timeline for completion of works under PMGSY III is March, 2025.

(b) The funds for implementation of PMGSY are released to the States/ UTs on the basis of the proposals received from them, and depend, inter-alia, on works in hand, execution capacity and unspent funds. Further release of funds to the Programme Implementation Units (PIUs) at the district level is done by the respective State Governments depending upon the absorption capacity of the PIUs.

Parliamentary Constituency wise details for PMGSY are not maintained by the Ministry. The details of PMGSY central funds released to Maharashtra, since 2019-20 are given below: -

The details of the funds utilized, State-wise, district-wise and year-wise under various interventions of Pradhan Mantri Gram Sadak Yojana (PMGSY) may be accessed at the program website omms.nic.in=>progress monitoring=>MPR 1.

(c) The State of Maharashtra has been allocated a target of 6,550 Km of road length under PMGSY-III. Out of this, the State has already been sanctioned 842 roads of 5477.50 km under PMGSY-III. The remaining length will be sanctioned in next batches on receipt of the proposal from State Government. Out of sanctioned length, State has completed 150 roads of 1718.72 km length under PMGSY-III. Further, the entire length allocated to the State has been distributed by the State among its rural districts. Accordingly, 40 roads of 217.64 km length has been sanctioned to the Satara district and out of which, 02 roads of 9.97 km length have already been completed under PMGSY-III.
