STATEMENT REFERRED TO IN REPLY TO PARTS (a) TO (e) OF UNSTARRED QUESTION NO. 1806 BY SHRI ARUN KUMAR SAGAR TO BE ANSWERED IN LOK SABHA ON 13.12.2023 REGARDING NEW RAILWAY LINE BETWEEN SHAHJAHANPUR-FARRUKHABAD

(a) to (e): Survey for construction of new line Farrukhabad-Shahjahanpur-Mailani (158 km) in North Eastern Railway was completed in 2018-19 with estimated project cost of ₹4168 crores.

As on 01.04.2023, total 71 Railway infrastructure Projects (16 New Lines, 4 Gauge conversion and 51 Doubling), of total length 6,552 km, costing ₹98,015 crores falling fully/partly in Uttar Pradesh are under different stages of planning/approval/execution, out of which 1498 km length has been commissioned and an expenditure of ₹28,275 crores has been incurred upto March, 2023. These include:

16 New Line Projects of total length 1,743 km costing ₹29,726 crores, out of which 260 km length has been commissioned and an expenditure of ₹7,162 crores has been incurred upto March, 2023.

4 Gauge Conversion Projects of total length 524 km costing ₹4,087 crores, out of which 238 km length has been commissioned and an expenditure of ₹1,519 crores has been incurred upto March, 2023.

51 Doubling Projects of total length 4,285 km costing ₹64,203 crores, out of which 1001 km length has been commissioned and an expenditure of ₹19,595 crores has been incurred upto March, 2023.

New Line, Gauge Conversion and Doubling Projects falling fully/partly in Uttar Pradesh are covered by Northern Railway, North Central Railway, North Eastern Railway, East Central Railway and West Central Railway zones of Indian Railways. Zone-wise details of all Railway Projects including cost, expenditure and outlay are made available in public domain on Indian Railways website.

Since 2014, there has been substantial increase in fund allocation and commensurate commissioning of projects across Indian Railways. Budget allocation for Infrastructure projects and safety works falling/partly in the state of Uttar Pradesh is as under:
