#### **SOLAR PUMPS**

Will the Minister of NEW AND RENEWABLE ENERGY be pleased to state:

- (a) the details of the number of units of solar pumps installed across the country at present;
- (b) the details of the profit being made by the farmers with these units;
- (c) whether the Government proposes to provide grid connected solar pumps to the farmers; and
- (d) if so, the details thereof and if not, the reasons thereof

#### **ANSWER**

#### THE MINISTER OF NEW & RENEWABLE ENERGY AND POWER

#### (SHRI R.K. SINGH)

- (a) The number of solar pumps installed under Components 'B' and 'C' of PM-KUSUM Scheme are furnished in **Annexure-I.**
- (b) to (d) The Component 'C' of PM KUSUM Scheme allows Solarisation of Grid Connected Agriculture Pumps through Individual Pump Solarisation (IPS) and through Feeder Level Solarization (FLS).

IPS provides farmers an opportunity to earn additional income by selling of power to the Distribution Companies. The additional income earned by farmers would vary from State to State and within a State depending on factors such a solar insolation, electricity price offered by the Distribution Company and capacity of solar panels installed. Most of the projects under this component of the Scheme have been commissioned during the recent years only and therefore, details related to profit made by farmers are yet to be reported by the State Implementation Agencies.

The number of pumps sanctioned and installed under IPS are also shown in **Annexure I.**
