**Har Ghar Jal Yojana in Karnataka**

1878. SHRI L.S. TEJASVI SURYA:

Will the Minister of JAL SHAKTI be pleased to state:

- (a) the status of completion of the Har Ghar Jal Yojana in the State of Karnataka, district-wise;
- (b) whether many of the districts in Karnataka did not have tap water connections before the launch of the scheme and if so, the percentage of households with water connection before and after the launch of the scheme, district-wise;
- (c) whether monitoring and auditing of the projects are done for verifying its completion and usage and if so, the details thereof;
- (d) the financial assistance provided for the Har Ghar Jal Yojana by the Union and State Governments so far, year-wise along with the total funds sanctioned by the Union Government for the project in the State of Karnataka; and
- (e) the timeline for the completion of the tap water connections in Karnataka?

**ANSWER**

(a) to (e) Government of India is committed to make provision for safe & potable tap water supply in adequate quantity, of prescribed quality and on a regular & long-term basis to all rural households in the country. Towards this end, the Government of India launched the Jal Jeevan Mission (JJM), to be implemented in partnership with states including Karnataka, in August 2019. Drinking Water is a state subject, and hence, the responsibility of planning, approval, implementation, operation, and maintenance of drinking water supply schemes, including those under the Jal Jeevan Mission, lies with State/UT Governments. The Government of India supports the States by providing technical and financial assistance.

Significant progress has been made in the country since the launch of Jal Jeevan Mission, towards enhancing access to tap water to rural households. At the start of Jal Jeevan Mission in August 2019, only 3.23 Crore (16.8%) rural households were reported to have tap water connections. So far, as reported by States/ UTs as on 11.12.2023, around 10.55 Crore additional rural households have been provided with tap water connections under JJM. Thus, as on 11.12.2023, out of 19.24

Crore rural households in the country, approximately 13.79 Crore (71.67%) households are reported to have tap water supply in their homes.

Similarly in Karnataka, at the start of Jal Jeevan Mission in August 2019, only 24.51 lakh (24.23%) rural households were reported to have tap water connections. So far, as reported by State, as on 11.12.2023, around 47.42 lakh additional rural households have been provided with tap water connections under JJM. Thus, as on 11.12.2023, out of 1.0117 Crore rural households in Karnataka, approximately 71.93 (71.10%) households are reported to have tap water supply in their homes. The district-wise details of household with tap water connection in Karnataka is **Annexed**. The state government has been advised to achieve the targets within the Mission Period.

To expedite the planning and implementation, as well as monitoring and handholding States/ UTs including Karnataka, Government of India has taken a number of steps which *inter alia* includes discussion and finalization of annual action plan (AAP) in consultation with States/ UTs, regular review of planning and implementation, workshops/ conferences/ webinars for capacity building and knowledge sharing, field visits by multi-disciplinary team to provide technical support, etc. To bring transparency and effective monitoring, an online 'JJM dashboard' has been created, which provides State/ UT, district, and village-wise progress as well as status of provision of tap water supply to rural homes. Third party inspection agencies have been deployed to ensure quality of implementation.

The year-wise details of funds allocated, released, and utilized by Karnataka along with state share, under Jal Jeevan Mission (JJM) are as under:
