NO. 1916. SHRI JAYANT SINHA:

Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) the targets and progress made under the Atal Mission for Rejuvenation and Urban Transformation (AMRUT) upto March, 2023;**
- (b) the funds allocated and disbursed for the State Annual Action Plans upto March, 2023, State-wise; and**
- (c) the details of utilisation of these funds by the State of Jharkhand?**

**ANSWER

(a): Atal Mission for Rejuvenation and Urban Transformation (AMRUT) focuses on the development of basic urban infrastructure in the sectors of Water Supply; Sewerage and Septage Management; Storm Water Drainage; Non-Motorized Urban Transport and Development of Green Spaces & Parks in selected 500 cities.

Targets and Progress under AMRUT till March 2023:

- Provided 137 lakh water tap connections (new/ serviced) against target of 139 lakh.**
- Provided 105 lakh sewer connections (new/ serviced) (including households covered through Faecal Sludge and Septage Management-FSSM) against target of 145 lakh.**
- Developed 2,840 Million Litre Per Day (MLD) Sewerage Treatment Capacity (STP),**
- Developed 1,437 Million Litre Per Day (MLD) capacity for reuse/recycle**
- Developed 3,289 Million Litre Per Day (MLD) Water Treatment Capacity (WTP).**

- **1,073.02 km length of drains constructed resulting in eliminating 3,319 numbers of water logging points.**
- **Developed 4,512 acres of Green space.**
- **Developed 419.85 km pedestrian/ walkway and 37.82 km of cycle track.**

(b): Against Central share of ₹35,990 crore for projects, ₹32,119 crore have been released upto March '23. Overall, ₹38,717 crore have been released under various components of AMRUT such as projects, Administrative & Office Expense (A&OE), Reforms incentive, JnNURM (erstwhile) projects and sub-schemes of GIS and Local Area Plan- Town Planning Scheme (LAP-TPS). State-wise status of funds released & Utilization Certificates (UCs) received in last three years under AMRUT is at ANNEXURE.

(c): In the State of Jharkhand under AMRUT, against the committed Central Assistance (CA) of ₹566.17 crore, for projects ₹551.69 crore has been released against which Utilization Certificates (UCs) have been received worth ₹422.28 crore. Overall, ₹616.75 crore central assistance has been released against which UCs have been received worth ₹481.78 crore.
