JJM in Odisha

1970. SHRI BASANTA KUMAR PANDA:

Will the Minister of JAL SHAKTI be pleased to state:

- (a) the details of Jal Jeevan Mission (JJM);
- (b) the number of beneficiaries, block-wise in the district of Kalahandi and Nuapada in Odisha since inception of JJM, year-wise;
- (c) the funds allocated to the State of Odisha as well as in above said districts since inception of JJM, year-wise;
- (d) the details of expenditure incurred by the State Government year-wise and in above said districts;
- (e) whether Government has provided tap water connection to every village in above said districts; and
- (f) if so, the details thereof and if not, the time by which it is likely to be completed?

ANSWER

**THE MINISTER OF STATE FOR JAL SHAKTI
(SHRI RAJEEV CHANDRASEKHAR)**

(a) to (f) Government of India is committed to make provision for safe & potable tap water supply in adequate quantity, of prescribed quality and on a regular & long-term basis to all rural households in the country, including those in the villages of Kalahandi and Nuapada districts in Odisha. Towards this end, the Government of India launched the Jal Jeevan Mission (JJM), to be implemented in partnership with states, in August 2019. Drinking Water is a state subject, and hence, the responsibility of planning, approval, implementation, operation, and maintenance of drinking water supply schemes, including those under the Jal Jeevan Mission, lies with State/ UT Governments. The Government of India supports the States by providing technical and financial assistance. States have been advised to complete all the works taken up under JJM within the Mission Period.

Significant progress has been made in the country since the launch of Jal Jeevan Mission, towards enhancing access to tap water to rural households. At the start of Jal Jeevan Mission in August 2019, only 3.11 lakh (3.51%) rural households were reported to have tap water connections in the

State of Odisha. So far, as reported by State as on 11.12.2023, around 57.66 lakh additional rural households have been provided with tap water connections under JJM. Thus, as on 11.12.2023, out of 88.64 lakh rural households in the country, approximately 60.77 lakh (68.56%) households are reported to have tap water supply in their homes. Year-wise and block-wise details of tap water connection in Kalahandi and Naupada districts of Odisha are **annexed**. Further, as on 11.12.2023, out of 2,016 villages in Kalahandi district, 1,641 are reported to have tap water connections. Similarly, out of 644 villages in Naupada district, 639 are reported to have tap water connections.

Under JJM, the funds are allocated and released State wise. Further distribution/ allocation of funds is done by respective States/ UTs and district-wise and project-wise fund allocations are not maintained centrally. Since launch of JJM in Aug, 2019, the details of funds allocated to the State of Odisha is given below:
