NO. 1971. SHRI KESINENI SRINIVAS:

Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) the details of funds allocated, released and utilized for projects under AMRUT 2.0 during the last three years, State-wise;**
- (b) the list of various projects undertaken and costs incurred as part of the AMRUT 2.0 scheme in Andhra Pradesh, especially in Vijayawada Municipal Corporation;**
- (c) the details of baseline household tap water and sewer/septage connections in Vijayawada and achievements of the scheme in reducing the gaps in service delivery so far;**
- (d) whether the Government has received any proposals from Andhra Pradesh under AMRUT 2.0 for projects related to the development of stormwater drainage, rejuvenation of water bodies and creation of community green spaces in Vijayawada; and**
- (e) if so, the details thereof?**

ANSWER

(a): The details of funds allocated, released and utilized for projects under Atal Mission for Rejuvenation and Urban Transformation (AMRUT) 2.0 during the last three years is at ANNEXURE-I.

(b): For the state of Andhra Pradesh, ₹2,948 crore has been allocated as Central Assistance (CA) for implementation of projects under AMRUT 2.0. So far, 552 projects worth ₹8517.69 crore (including Operations & Maintenance cost) have been approved by the Apex Committee for AMRUT 2.0 Mission in Ministry of Housing and Urban Affairs (MoHUA). Of these, Detailed Project Reports (DPRs) have been prepared for 316 projects worth ₹3,445.07 crore. Notice Inviting Tender (NIT) for 214 projects worth ₹2,395.91 crore have been issued. 180 projects worth ₹738.75 crore have been awarded, out of which, 8 projects worth ₹46.83 crore has been completed.

In Vijayawada Municipal Corporation, under AMRUT 2.0, 13 projects worth ₹593.37 crore have been approved by Apex Committee of Ministry of Housing and Urban Affairs. The list of various projects taken under AMRUT 2.0 in Vijayawada district is Attached as ANNEXURE-II.

(c): Water & Sanitation is a State subject and management of water & sanitation are State Governments' responsibility. However, Ministry of Housing and Urban Affairs supplement the efforts of the State/ Urban Local Bodies (ULBs) in these sectors through various flagship programmes like AMRUT & AMRUT 2.0. As reported by the State, for Vijayawada Municipal Corporation, the number of households with tap connections are 2,31,140 and number of households with sewer connections are 1,51,739 for the year 2021. Through the projects approved by apex committee, a total number of 45,956 household tap water connections and 21,576 household sewer/ septage connections have been proposed for Vijayawada Municipal Corporation under AMRUT 2.0.

(d) & (e): A total of 05 projects worth ₹30.55 crore for rejuvenation of water bodies have been approved by Apex committee MoHUA under AMRUT 2.0 in Vijayawada Municipal Corporation. The details are attached as ANNEXURE-III.
