During the financial year 2021-22, out of the budget of Rs. 41.99 crore earmarked for CSR activities, HUDCO has contributed Rs. 25.00 crores to 'PM CARES Fund' and the remaining unspent amount of Rs. 16.99 crore was transferred to 'Swachh Bharat Kosh' in accordance with the provisions of CSR in Companies Act 2013. In addition to this, an expenditure of Rs. 4.47 crore was incurred for the 'Ongoing Projects' approved in earlier years.

During the financial year 2022-23, out of the budget of Rs. 44.98 crore earmarked for CSR activities, CSR assistance of Rs. 26.68 crore was approved for 19 proposals. However, no expenditure was incurred on these proposals during the financial year and as such, the amount of Rs. 26.68 crore was transferred to 'Unspent CSR account 2023' opened with a scheduled bank for utilization in next 3 financial years as per provisions of CSR in Companies Act 2013. Further, the remaining unspent amount of Rs. 18.30 crore was transferred to 'PM CARES FUND' in accordance with the provisions of CSR in Companies Act 2013. In addition to this, an expenditure of Rs. 3.21 crore was incurred for the 'Ongoing Projects' approved in earlier years.
