Subsidy on LPG Cylinders to Consumers

2003. SHRI SISIR KUMAR ADHIKARI:

Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state:

- (a) whether it is a fact that subsidy on LPG Cylinder to consumers for the year 2023-24 has been increased as compared to previous years;
- (b) if so, the details thereof;
- (c) the current status of Pradhan Mantri Ujjwala Yojana (PMUY) in the country;
- (d) the details of the current active consumers, subsidy received and average refill of cylinder per year during the last five years and the current year, State/UT-wise;
- (e) whether the PMUY beneficiaries are paying more for 14.2 KG cylinders and 10 KG cylinders as against the market price of the same; and
- (f) if so, the details thereof?

(a) to (d): Yes Sir.

As of 01.11.2023, there are 31.64 crore active domestic LPG consumers. The state-wise details of active consumers are given at Annexure-I and the details of annual domestic LPG sales by Public Sector Oil Marketing Companies are given at Annexure-II.

Pradhan Mantri Ujjwala Yojana (PMUY) was started in May, 2016 with the objective of providing access to clean cooking fuel to poor households in the country according to a defined criteria. Under PMUY, deposit free LPG connections are provided to adult women from poor households. More than 100.85 crore refills have been taken by PMUY beneficiaries in the last 3 years alone. Per capita consumption of PMUY beneficiaries has increased from 3.01 Refills/annum (in terms of 14.2 Kg refill) during FY 2019-20, to 3.71 Refills/annum during FY 2022-23 & further to 3.8 refills in 2023-24 (till October 2023). State-wise and year-wise details of PMUY beneficiaries are given at Annexure-III.

India imports more than 60% of its domestic LPG consumption. Price of LPG in the country is linked to its price in the international market. Government continues to modulate the effective price to consumer for domestic LPG. During the period 2020-21 to 2022-23, the average Saudi CP (international benchmark for LPG pricing) went up from \$415 per MT to \$712 per MT. However, the increase in the international prices was not fully passed on to the customers. Government has reduced the Effective Price of domestic LPG by Rs. 200 per 14.2 Kg LPG cylinder with effect from 30th August, 2023. The Retail Selling Price of domestic LPG was Rs. 903 per 14.2 Kg LPG cylinder on 1st September 2023 and there has been no change in price since then.

W.e.f. 21st May, 2022, Government has been providing a budgetary support for targeted subsidy of Rs. 200 per 14.2 Kg LPG cylinder for Pradhan Mantri Ujjwala Yojana (PMUY) beneficiaries for upto 12 refills a year for years 2022-23 and 2023-24. Moreover, w.e.f. 5th October, 2023, the targeted subsidy has been further increased to Rs. 300 per 14.2 Kg LPG cylinder for Pradhan Mantri Ujjwala Yojana (PMUY) beneficiaries.

Funds under DBTL and PMUY are not allocated/utilized state-wise. Details of subsidy on domestic LPG given by Government since 2018-19 are given below:
