- (a) the number of urban development schemes implemented in the State of Tamil Nadu and Odisha during each of the last three years and the current year, year-wise;**
- (b) the funds allocated and utilized for urban development schemes during each of the last three years and the current year;**
- (c) the challenges being faced by the Government while implementing urban development schemes; and**
- (d) the steps taken by the Government to achieve the target set under urban development schemes?**

- (a) to (d) Urban Development is a State subject. However, the Ministry of Housing and Urban Affairs assists the States/Union Territories (UTs), including Tamil Nadu and Odisha, in development of urban infrastructure through its Missions- Atal Mission for Rejuvenation and Urban Transformation 2.0 (AMRUT 2.0), Smart Cities Mission (SCM), Swachh Bharat Mission-Urban 2.0 (SBM-U 2.0) and Pradhan Mantri Awas Yojana-Urban (PMAY-U). The progress of the Missions / schemes is continuously monitored at the Central and State levels through meetings, video conferencing, field visits, institutional mechanisms comprising of Management Information System (MIS) and third party evaluation. Details of funds allocated/released and utilised by the States of Tamil Nadu and Odisha in these schemes during the last 3 years and the current financial year are given in Annexure-I.**
