## be pleased to state:

- (a) the details of the losses incurred by various National Highways during the last five years due to damage caused by heavy rains and other reasons;
- (b) whether the National Highways Authority of India (NHAI) and other agencies have inspected the drainage system as well as the roads in view of the increased carrying capacity of the roads and for the smooth movement of vehicles;
- (c) if so, the details thereof and the corrective steps being taken in this regard along with the expenditure incurred for this purpose, State/UT-wise and if not, the reasons therefor; and
- (d) whether the Government has no plan other than the proposed asset monetisation of National Highways and if so, the details thereof?

#### **ANSWER**

#### THE MINISTER OF ROAD TRANSPORT AND HIGHWAYS

### (SHRI NITIN JAIRAM GADKARI)

(a) to (c) State / Union Territory (UT) - wise details of reported length of damaged National Highways (NHs) during the last five years, including damages due to heavy rains and other factors, are at Annexure-I.

Development and maintenance of NHs is a continuous process. The conditions of NHs are assessed from time to time and specially before monsoon by the Ministry through its various executing agencies such as National Highways Authority of India (NHAI), National Highways & Infrastructure Development Corporation Limited (NHIDCL), Border Roads Organisation (BRO), National Highways Logistics Management Limited (NHLML), Public Works Departments (PWDs) / Road Construction Departments (RCDs) / Corporations of State Governments/ Union Territories (UTs). The works on NHs are accordingly taken up from time to time as per traffic density, inter-se priority and availability of funds to keep the NHs in traffic worthy conditions; such works also include rectification of deficiencies and damages caused due to various rehabilitation and strengthening NHs. reasons, of capacity augmentation to higher lane configurations, providing adequate drainage systems, etc.

Provision of adequate drainage system is an integral part of development of NHs. Appropriate camber/cross fall is provided to the wearing surface of the roads to drain off the rain water at the earliest. The drain off water is collected in longitudinal drain and eventually goes

to the cross drains or streams. These aspects are taken care of during the design & construction of NHs. The NHs are provided with longitudinal lined/unlined drains and cross drains depending on the site requirement in accordance with the Indian Road Congress (IRC) guidelines.

The Ministry has evolved a mechanism to ensure Maintenance and Repair (M&R) of all NHs sections through accountable maintenance agency.

The M&R of stretches of NHs, where Development works have commenced or Operation, Maintenance and Transfer (OMT) Concessions/ Operation and Maintenance (O&M) Contracts have been awarded, are the responsibility of the concerned Concessionaires/ Contractors till the end of the Defect Liability Period (DLP)/ the Concession Period. Similarly, for NHs stretches undertaken under TOT (Toll Operate and Transfer) and InvIT (Infrastructure Investment Trust), M&R responsibility lies with concerned Concessionaire till the end of the Concession Period.

For remaining NHs stretches, Ministry has taken policy decision to undertake maintenance works either through Performance based Maintenance Contract (PBMC) or Short Term Maintenance Contract (STMC) only, by phasing out the conventional types of M&R works like Ordinary Repairs (OR), Periodical Renewals (PR), Special Repairs (SR) and Flood Damage Repairs (FDR) taken up earlier.

Expenditure for development and maintenance of NHs is incurred by different agencies e.g. NHAI, NHIDCL, BRO, NHLML and State/UT Government. Year - wise details of funds allocated and expenditure incurred / funds released under Agencies (other than State/UT government) / Schemes for development and maintenance of NHs during the last five years are placed at Annexure-IIA and Annexure-IIIA respectively. For works being executed through State / UT Governments, State / UT - wise details of funds allocated and expenditure incurred / funds released for development and maintenance of NHs during the last five years are placed at Annexure-IIB and Annexure-IIIB respectively.

(d) Apart from the Budgetary support for the NHs projects, other sources of funds include monetization of NHs through InvIT (Infrastructure Investment Trust) and Project based financing modes. In addition, Private Investment is also done for NHs under Public Private Partnership (PPP) Projects.

Ministry, through NHAI, has raised Rs. 70,127 Crore so far through the monetization of NHs through TOT (Toll Operate and Transfer), InvIT and Project based financing modes. Additionally, Private Investment of Rs. 1,12,095 Crore has been done for NHs under PPP Projects so far since 2018-19.
