Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) whether the Government is implementing Atal Mission for Rejuvenation and Urban Transformation 2.0 (AMRUT 2.0);
- (b) if so, the details of cities covered under AMRUT 2.0, State/UT-wise;
- (c) the details of fund allocated and disbursed to the States/UTs, State/UT-wise;
- (d) the details of budgetary allocation made for the AMRUT 2.0 projects during mission period, State/UT-wise; and
- (e) the status of implementation of AMRUT (1.0) projects in Tamil Nadu?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF HOUSING AND URBAN AFFAIRS (SHRI KAUSHAL KISHORE)

(a) & (b): Yes, Sir. The Government is implementing Atal Mission for Rejuvenation and Urban Transformation (AMRUT) 2.0 launched in October 2021, to make the cities 'water secure'. It focuses on providing functional tap connections in 4,902 towns/ cities across the country and universal household coverage of sewage/ septage coverage in 500 AMRUT cities. To achieve this, projects for Water Supply; Rejuvenation of water bodies and developing green spaces & parks; and Sewerage and Septage Management and reuse of treated water and other important focus areas are taken up. (c) & (d): The total budgetary allocation for the projects under AMRUT 2.0 mission is ₹66,750 crore. The State/ UT wise allocation and disbursement of funds for the projects & Administrative & Other Expenses (A&OE) is at ANNEXURE.

(e): Under AMRUT, the approved State Annual Action Plan (SAAP) size of Tamil Nadu is ₹11,194.78 crore, including the committed Central Assistance of ₹4,756.58 crore and ₹4,397.29 crore has been released till date. And so far, for the State of Tamil Nadu, 445 projects were sanctioned for ₹13,339.43 crore. Out of these, 424 projects worth ₹3,392 crore have been completed and remaining 21 projects worth ₹9,947 crore are under implementation. As reported by the State, the current expenditure on these projects is ₹10,841 crore.
