#### IMPLEMENTATION STATUS OF AB-PMJAY

2110. SHRI JAYANT SINHA: SHRI MAHESH SAHOO: SHRI CHANDESHWAR PRASAD:

Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) the implementation status of Ayushman Bharat Pradhan Mantri Jan Arogya Yojana (AB-PMJAY), State/UT-wise:
- (b) the number of persons benefited under ABPMJAY since inception, State/UT-wise including district-wise in Odisha, Jharkhand and Jehanabad, Arwal and Gaya districts in Bihar;
- (c) whether a number of households from rural areas have not been enrolled under AB-PMJAY thereby being deprived of the benefits under the Yojana and if so, State/UT-wise details thereof and corrective steps taken by the Government in this regard; and
- (d) the total expenditure incurred by the Government under the Yojana since 2019-2020, State/UT-wise?

# ANSWER THE MINISTER OF STATE IN THE MINISTRY OF HEALTH AND FAMILY WELFARE (PROF. S. P. SINGH BAGHEL)

(a) to (d): As on 12.12.2023, approximately 28.1 crore Ayushman cards have been created and over 6.06 crore hospital admissions worth Rs. 78,372 crore have been authorized under Ayushman Bharat -Pradhan Mantri Jan Arogya Yojana (AB-PMJAY). States/UT of Odisha, West Bengal and Delhi are not implementing AB-PMJAY. State/UT-wise details of implementation of the scheme, along with the number of persons benefited since inception, are at **Annexure-I**.

In the State of Jharkhand, Ayushman Bharat Pradhan Mantri - Jan Arogya Yojana is being implemented in convergence with State-specific scheme - Mukhyamantri Jan Arogya Yojana (MMJAY). District-wise details of number of authorized hospital admissions under the scheme in

the State of Jharkhand are at **Annexure-II**. With respect to Jehanabad, Arwal and Gaya districts in Bihar, the details of authorized hospital admissions are as under:

Approximately 55 crore individuals corresponding to 12 crore families are covered under AB-PMJAY. Further, States/UTs have expanded the beneficiary base at their own cost. Under the scheme, all eligible beneficiary families are covered since inception of the implementation of the scheme in the States/UTs. The absence of Ayushman Card does not hinder any eligible individual from taking treatment under the scheme. Ayushman cards are issued as a token of entitlement and empowerment. Since the nature of the scheme is demand-driven, beneficiaries generally create Ayushman cards when they are in need of any medical treatment.

Massive Ayushman card creation drive across the country is undertaken in tandem with the States. The details of different initiatives taken under the scheme to saturate Ayushman card are as follows:

- i. Ayushman Bhava: Ayushman Bhava, launched by Hon'ble President, Smt. Droupadi Murmu, on 12.09.2023, is an initiative that is aimed at ensuring the saturation of various healthcare schemes at the village level, ultimately reaching the end beneficiaries. This initiative encompasses a series of interventions, including 'Aapke Dwar Ayushman 3.0', 'Ayushman Sabhas', 'Ayushman Melas', and the ultimate goal of elevating villages to the status of 'Ayushman Gram'.
- ii. Ayushman App: An Android based 'Ayushman App' has been developed using latest technology that provides for modes of authentication i.e. face-auth, OTP, IRIS, and fingerprint for creation of Ayushman card.
- iii. Aapke Dwar Ayushman: ADA 3.0 has been launched on 17.09.2023 as part of Ayushman Bhava campaign, wherein self-verification feature for beneficiaries through Ayushman App has been enabled.

Since FY 2019-20, a total of 5.9 crore hospital admissions worth Rs. 75,108 crore have been authorized under the scheme. State/UT-wise details of the amount of authorized hospital admissions since FY 2019-20 are at **Annexure-III**.
