The requirement of fertilizers in the country is assessed by DA&FW in coordination with the State Governments. The requirement of fertilizers is met through indigenous production and timely imports. In case of Urea, the imports are done on Government account through 3 designated STEs namely Indian Potash Ltd. (IPL), Rashtriya Chemicals & Fertilizers Ltd. (RCF) & National Fertilizers Ltd. (NFL) and through a long term Urea imports arrangement with OQ trading (Oman). Further, P&K fertilizers are under Open General License and companies are importing these fertilizers to meet the demand based upon their commercial considerations.
