SABLA SCHEME

Will the Minister of WOMEN AND CHILD DEVELOPMENT be pleased to state:

- (a) Whether the Government has launched the Scheme for Empowerment of Adolescent Girls- SABLA, if so, the details thereof along with the achievements made thereunder so far;
- (b) the criteria fixed for identifying the beneficiaries under this scheme along with the number of adolescent girls benefited there under since its inception;
- (c) the details of the scheme to formulated to raise awareness about the SABLA and the outcome thereof;
- (d) the details and the outcome of the performance review of the SABLA scheme along with the challenges being faced in its implementation; and
- (e) whether the said scheme is proposed to be expanded to additional districts, if so ,the details thereof and the steps taken thereon indicating the quantum of nutritional supplements released there under during the last three years and the current year, States /UT-wise?

ANSWER

MINISTER OF WOMEN AND CHILD DEVELOPMENT (SHRIMATI SMRITI ZUBIN IRANI)

(a) to (e): For self-development and empowerment of adolescent girls in the age group of 11- 18 years, Rajiv Gandhi Scheme for Empowerment of Adolescent Girls -SABLA was launched in 2010 on pilot basis in 205 districts of the country. The scheme was renamed as Scheme for Adolescent Girls and extended to additional 303 districts across the country in 2017-18. Thereafter, with effect from 01.04.2018, the Scheme was extended to all the districts of the country covering only out-of-school adolescent girls in the age group of 11-14 years. With the enforcement of Right to Education Act, 2009,

there was a decline seen in the number of beneficiaries of the Scheme since the RTE Act provides legal entitlement for compulsory and free education to adolescent girls in the age group of 11-14 years and all the adolescent girls are entitled to go to school. Keeping this in view, Scheme for Adolescent Girls was revised w.e.f. 01.04.2022 and was subsumed under Mission Saksham Anganwadi and Poshan 2.0. The Scheme aims at providing nutritional support to Adolescent Girls (14-18 years) for improving their health and nutritional status in the Aspirational Districts and all North Eastern States.

This scheme consists of two components, viz., nutrition and non-nutrition. Under nutrition component, supplementary nutrition including micronutrients is provided in the form of Take Home Ration (THR) (not raw food material) for maximum of 300 days in a year. The non-nutrition component is based on convergence with different ministries wherein IFA supplementation, health check-up and referral services, nutrition &health education, skill training etc. is provided.

The beneficiaries under this scheme are Adolescent Girls in the age group of 14-18 years. The details regarding State-wise number of beneficiaries under the Scheme are given at **Annexure – I**.
