NON-AVAILABILITY OF MARKET FOR AGRICULTURAL PRODUCE

241. SHRI GOPAL CHINNAYA SHETTY:

Will the Minister of AGRICULTURE AND FARMERS WELFARE कृषि एवं किसान कल्याण मंत्री be pleased to state:

- (a) whether farmers have to destroy their produceof tomato, onion etc. due to non-availability ofmarket on a large scale across the country, especiallyin the State of Maharashtra;
- (b) if so, the details thereof particularly for the State of Maharashtra;
- (c) whether efforts have been made to providerelief to the farmers by bringing them under theambit of Food Plaza and if so, the details thereof;
- (d) the names of places where these food plazashave been established in the country, particularly inthe State of Maharashtra; and
- (e) the other measures proposed to be taken bythe Government in this regard so that the farmers do not destroy their produce?

ANSWER

MINISTER OF AGRICULTURE AND FARMERS WELFARE कृषि एवं किसान कल्याण मंत्री (SHRI NARENDRA SINGH TOMAR)

(a) & (b): Agricultural marketing is a state subject and wholesale markets are set up under the provisions of respective State Agricultural Produce Market Committee (APMC) Act. However, in order to reduce supply chain losses, promote competition and encourage private sector investment in development of value chain and marketing infrastructure of perishable horticultural produce, Department of Agriculture & Farmers Welfare (DA&FW), has been pursuing with the States to de-regulate marketing of fruits and vegetables outside the market yards. Responding to pursuance, most of the State Governments have deregulated fruits and vegetables.

As per the information received from Maharashtra State Agricultural Marketing Board, Pune, "In order to reduce the price gap between producers and consumers through reduction in intermediaries Maharashtra State has deregulated fruits and vegetables outside the Agricultural Produce Market Committee (APMC) yards in July, 2016. To overcome forced sale of onion, chawl capacity of about 29.75 lakh MT has been created. For tomatoes the current rates are in range of Rs.2084 to Rs.2508 per Qtl. However, the destroy of produce has not been recorded". The arrival & modal price of onions for last 03

years in the APMCs of Maharashtra is at Annexure-I. The arrival & modal price for tomatoes for last 03 years in the APMCs of Maharashtra is at Annexure-II.

(c) to (e): As per the information received from Ministry of Food Processing Industries (MoFPI), MoFPI has been implementing Mega Food Park Scheme (MFPS), a component scheme under the Pradhan Mantri Kisan Sampada Yojana (PMKSY), to create modern infrastructure for the food processing sector along the value chain from farm to market. Ministry does not set up Mega Food Parks on its own. The scheme is demand driven and proposals are invited through Expression of Interest. Under the scheme, Ministry had approved 41 Mega Food Parks (MFPs) in the country. State-wise details of the 41 MFPs is at Annexure-III. This scheme has been discontinued by the Government with effect from 01.04.2021 with provision for committed liabilities for ongoing projects.

As per the information received from Maharashtra State Agricultural Marketing Board, Pune, "Recently in the year 2020-21 the Maharashtra Agribusiness Network Project (MAGNET) is started with support of Asian Development Bank for value chain development of Horticultural Crops. With objective to Increase farmers income while promoting commercially attractive private investment in selected value chains namely Pomegranate, Banana, Custard apple, Guava, Sapota, Orange, Sweet orange, Strawberry, Okra, Chilly (red and green), Flowers etc."

Government of India is implementing Market Intervention Scheme (MIS)for procurement of agricultural and horticultural commodities which are perishable in nature and are not covered under the Price Support Scheme (PSS). The objective of intervention is to protect the growers of these commodities from making distress sale in the event of a bumper crop during the peak arrival period when the prices tend to fall below economic levels and cost of production. The condition is that there should be either at least a 10 percent increase in production or a 10 percent decrease in the ruling market prices over the previous normal year. The scheme is implemented at the request of a State/UT government which is ready to bear 50 percent of the loss (25 percent in case of North-Eastern States), if any, incurred on its implementation. The extent of total amount of loss to be shared on a 50:50 basis between the Central Government and the State Government is restricted to 25 percent of the total procurement value which includes cost of the commodity procured plus permitted overhead expenses. Under the scheme, in accordance with MIS quidelines, a pre-determined quantity at the fixed Market Intervention Price (MIP) is procured by the agencies designated by the State Government for a fixed period or till the prices are stabilized above the MIP whichever is earlier.

Further, Government of India is also implementing a Central Sector Scheme Agriculture Infrastructure Fund (AIF) of Rs 1,00,000 crore to provide a medium –long term loan facility for investment in viable projects for post-harvest infrastructure including warehousing facility and community farming assets through interest subvention and financial support.

With a view to promote exports and reduce imports of high value horticulture crops, the Ministry of Agriculture and Farmers' Welfare, Government of India had launched the Horticulture Cluster Development Programme (CDP) in May 2021. In the pilot phase, 12 horticulture clusters were selected including Nasik for Grapes and Solapur for Pomegranate from Maharashtra state. This programme is designed to leverage the geographical specialization of horticulture clusters and promote integrated and market led development of pre-production, production, post-harvest, logistics, branding and marketing activities.

Government is also implementing Mission for Integrated Development of Horticulture (MIDH) under which financial assistance is provided for various horticulture

activities including post-harvest management infrastructure such as construction/ Expansion/Modernization of cold storages of capacity up to 5000 MT, purchase of refrigerated transport vehicle for 9MT and prorate basis for lesser capacity but not below 4MT and market infrastructure such as creation of wholesale market, rural primary market, functional infrastructure etc in the country. These components are demand/entrepreneur driven for which Government assistance in the form of credit linked back ended subsidy is available through respective State Horticulture Missions.
