ALLOCATION TO PMKSY

2572. SHRI MAGUNTA SREENIVASULU REDDY: SHRI VIJAY KUMAR DUBEY:

Will the Minister of **FOOD PROCESSING INDUSTRIES** be pleased to state:

- (a) the funds allocated under Pradhan Mantri Kisan Sampada Yojana (PMKSY) Scheme;
- (b) the details of the component schemes being run under the PMKSY;
- (c) the distribution of the sanctioned amount between the sub-schemes under PMKSY;
- (d) whether the Ministry has conducted any study to analyse the working of the sub-schemes;
- (e) if so, the outcomes thereof and if not, the reasons therefor; and
- (f) the details of the type of model prepared thereunder by the Government, State-wise including Uttar Pradesh?

ANSWER

THE MINISTER OF STATE FOR FOOD PROCESSING INDUSTRIES (KM. SHOBHA KARANDLAJE)

(a) to (c) : A total outlay of Rs. 6000 crore for the 14th Finance Commission cycle and Rs. 4600 crore for the 15th Finance Commission cycle have been allocated for the Central Sector Umbrella Scheme - Pradhan Mantri Kisan Sampada Yojana (PMKSY). Under PMKSY, financial assistance in the form of grants-in-aid has been provided to the approved projects under the following component schemes of PMKSY:

- Mega Food Parks Scheme (MFP Scheme)
- Integrated Cold Chain and Value Addition infrastructure (Cold Chain Scheme)
- Creation of Infrastructure for Agro Processing Cluster (APC Scheme)
- Creation/ Expansion of Food Processing And Preservation Capacities (CEFPPC Scheme)
- Creation of Backward and Forward Linkages (CBFL Scheme)
- Operation Greens (OG Scheme)
- Food Safety and Quality Assurance Infrastructure Setting up/ Upgradation of quality control/ food testing laboratories (FTL)
- Human Resource & Institutions (HRI)

A total of Rs. 6067.47 Crore has been sanctioned, the details of distribution of sanctioned amount in the form of grants-in-aid to the approved food processing projects under various component-schemes of PMKSY are given at **Annexure-I.**

(d) to (e) : Evaluation studies have been conducted for component schemes of PMKSY viz. Scheme for Integrated Cold Chain and Value Addition Infrastructure, Food Safety & Quality Assurance Infrastructure, Scheme for Creation/ Expansion of Food Processing and Preservation Capacities, Scheme for Creation of Infrastructure for Agro Processing Clusters and Scheme for Human Resource and Institutions - Skill Development and Research & Development of PMKSY. A brief of the studies conducted in respect of various component schemes of PMKSY are at **Annexure-II.**

(g) The detailed guidelines have been framed for the component schemes of PMKSY based upon which proposals are scrutinized and thereafter considered for approval on merit. Further, PMKSY is demand driven and proposals/applications are invited by the Ministry under its component schemes by issuing Expression of Interests (EoI) from time to time.
