BENEFICIARIES UNDER PMAY-G IN TAMIL NADU

2601. SHRI PARTHIBAN S.R.:

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) the total number of beneficiaries under Pradhan Mantri Awaas Yojana-Gramin (PMAY-G) during the years 2021-22 and 2022-23, State and district-wise particularly in Tamil Nadu;
- (b) the details of the houses allotted, State and district-wise particularly in Tamil Nadu; and
- (c) whether the Government is planning to increase the number of beneficiaries under PMAY-G, if so, the details thereof and if not, the reasons therefor?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SADHVI NIRANJAN JYOTI)

(a) In order to achieve the target of "Housing for All" in rural areas, the Ministry of Rural Development is implementing Pradhan Mantri Awaas Yojana- Gramin (PMAY-G) with effect from 1st April 2016 to provide assistance to construct 2.95 crore pucca houses with basic amenities by 2024. The total target of 2.95 crore houses has already been allocated to States/Union Territories (UTs) of which more than 2.94 crore houses has been sanctioned to the beneficiaries by various States/ UTs and 2.51 crore houses have been completed.

The total number of houses sanctioned to the beneficiaries by the States/UTs under Pradhan Mantri Awaas Yojana-Gramin (PMAY-G) during the years 2021-22 and 2022-23 (state-wise) is given at Annexure – I. The district level data related to houses allocated, sanctioned and completed and funds transferred to beneficiaries can be seen at the programme website at www.pmayg.nic.in---->AwaasSoft---->Reports---->Houses progress against the target financial year.

- (b) The detail of houses allotted under PMAY-G (state-wise) is given at Annexure II and the district-wise allocation in Tamil Nadu is given at Annexure III. The details of houses allotted for districts of other States/UTs can be seen at the programme website at www.pmayg.nic.in---->AwaasSoft---->Reports----> Annual target and allocation report.
- (c) The Union Cabinet had approved the overall target of construction of 2.95 crore houses under PMAY-G by 31st March, 2024. The total target of 2.95 crore houses has been allocated to the States/UTs, against which more than 2.94 crore houses have been sanctioned by the States/UTs and 2.51 crore houses have been completed as on 13.12.2023. At present, there is no proposal under consideration of the Ministry for enhancing the coverage of the PMAY-G beyond March 2024.
