PACS in Chhattisgarh

Will the Minister of COOPERATION (सहकारिता मंत्री) be pleased to state:

- (a) the features of the Primary Agricultural Credit Societies (PACS);
- (b) whether the Government is collecting data under the PACS; and
- (c) if so, the details thereof for the State of Chhattisgarh, district-wise?

ANSWER

THE MINISTER OF COOPERATION सहकारिता मंत्री (SHRI AMIT SHAH)

(a): Primary Agriculture Credit Societies (PACS) constitute the lowest tier of the Short-Term Cooperative Credit Structure (STCCS) in the country, primarily providing short-term and medium-term credit facility and other input services, like seed, fertilizer, pesticide distribution, etc. to member farmers. PACS are refinanced by NABARD through District Central Cooperative Banks (DCCBs) and State Cooperative Banks (StCBs). Presently, around 13 crore farmers are linked with PACS. Being the grassroots level cooperative institutions, PACS play a crucial role in sustaining the rural economy of the country by purveying institutional credit to small and marginal farmers.

In order to transform PACS into vibrant economic entities at Panchayat/ village level Model Byelaws have been framed by this Ministry and circulated to all the States/ UTs on 5th January, 2023 for their adoption by PACS after making suitable changes as per respective State Cooperative Acts. Model Byelaws have been adopted by 31 States/ UTs so far.

Model Byelaws will enable PACS to undertake more than 25 business activities, including dairy, fishery, setting up godowns, procurement of foodgrains, fertilizers, seeds, LPG/Petrol/Diesel distributorship, short-term & long-term credit, custom hiring centers, Fair Price Shops (FPS), community irrigation, Business Correspondent activities, Common Service Centre, etc.

(b) and (c): A comprehensive National Cooperative Database is being developed by Ministry of Cooperation, Government of India, with the support of State Governments. The data of all the Cooperative Societies from various sectors, including PACS, is being entered in the database by nodal officers appointed by the States /UTs for this purpose. So far, data related to around 8 lakh cooperative societies has been collected, out of which 1,03,559 are PACS/ Large Area Multi-purpose Societies (LAMPS)/ Farmers Service Society (FSS). The district wise details of cooperative societies in the State of Chattisgarh are enclosed at Annexure.
