UNREGISTERED FOOD PROCESSING UNITS

2744. SHRI VIJAY KUMAR DUBEY:

Will the Minister of FOOD PROCESSING INDUSTRIES be pleased to state:

- (a) whether the Government proposes to set up Food Processing Units in the country;
- (b) if so, the details thereof;
- (c) the details of the un-incorporated unregistered food processing zones and units presently operating in the country, State-wise including those of Uttar Pradesh; and
- (d) whether the Government has implemented a Centrally Sponsored Scheme namely, Pradhan Mantri Formalisation of Micro Food Processing Enterprises (PMFME) with an approach of 'One District, One Product' and if so, the details thereof?

ANSWER

THE MINISTER OF STATE FOR FOOD PROCESSING INDUSTRIES (KM. SHOBHA KARANDLAJE)

- (a) to (b): The Ministry of Food Processing Industries (MoFPI) has been implementing a Central Sector umbrella scheme— Pradhan Mantri Kisan Sampada Yojana (PMKSY) since 2017-18. Under component scheme Creation/ Expansion of Food Processing and Preservation Capacities (CEFPPC scheme) of PMKSY, MoFPI supports eligible entities for setting up/ expansion of food processing units across the country.
- (c) : As per 73rd Round Survey of National Sample Survey Organisation (NSSO) [July 2015 June 2016], there are about 25 lakh unregistered / unincorporated food processing enterprises in the country. The details of State-wise number of unregistered / unincorporated food processing enterprises in the country are at **Annexure.**
- : Yes, Sir. Ministry of Food Processing Industries is also implementing a Centrally (d) Sponsored "PM Formalisation of Micro food processing Enterprises (PMFME) Scheme" with a total outlay of Rs. 10,000 crore for a period of five years from 2020-21 to 2024-25. PMFME provides financial, technical and business support for upgradation of micro food processing enterprises in the country. The scheme has adopted One District One

Product (ODOP) approach to reap the benefit of scale in terms of procurement of inputs, availing common services and marketing of products. ODOP for the scheme provides the framework for value chain development and alignment of support infrastructure.

The details of assistance provided under PMFME scheme are as under:

- (i) Support to Individual / Group Category Micro Enterprises: Credit-linked capital subsidy @35% of the eligible project cost, subject to maximum of Rs. 10.00 lakh per unit.
- (ii) Support to SHGs for seed capital: Seed capital @ Rs. 40,000/- per member of SHG engaged in food processing for working capital and purchase of small tools subject to maximum of Rs. 4.00 lakh per SHG Federation.
- (iii) Support to Common Infrastructure: Credit linked capital subsidy @35% subject to maximum of Rs. 3.00 crore to support FPOs, SHGs, Cooperatives and any Government agency for setting up of common infrastructure.
- (iv) Branding and Marketing Support: Grant up to 50% for Branding and Marketing to groups of FPOs/SHGs/Cooperatives or an SPV of micro food processing enterprises.
- (v) Capacity Building: Scheme envisages training for Entrepreneurship Development Skilling program (EDP+) program to meet the requirement of food processing industry and product specific skilling.
