Will the Minister of **FISHERIES, ANIMAL HUSBANDRY AND DAIRYING** मत्स्यपालन, पशुपालन और डेयरी मंत्री be pleased to state:

- (a) the reason for restructuring of the National Programme for Dairy Development in 2021;
- (b) the manner in which the scheme ensure that the quality of milk and milk products is enhanced and that the share of organised procurement and processing of milk is increased;
- (c) the total number of projects that have been approved in Pali, Jhansi, Pratapgarh, Navsari and Balasore Parliamentary Constituency under NPDD scheme;
- (d) the details of funds released to Pali, Jhansi, Pratapgarh, Navsari and Balasore parliamentary constituency for the projects, Project-wise;
- (e) the status of all the projects in Pali, Jhansi, Pratapgarh, Navsari and Balasore parliamentary constituency under the said scheme; and
- (f) the status of the project approved for Cooperative Dairy Federation, State-wise including Rajasthan which covers Pali district and above mentioned Parliamentary Constituencies?

ANSWER

THE MINISTER FOR FISHERIES, ANIMAL HUSBANDRY AND DAIRYING (SHRI PARSHOTTAM RUPALA)

(a) & (b) Department of Animal Husbandry & Dairying (DAHD) is implementing "National Programme for Dairy Development (NPDD)" scheme across the country since Feb-2014. Based on the recommendations of the evaluating agency in the study of developmental schemes of the Department including National Programme for Dairy Development (NPDD) scheme conducted by NITI Aayog, NPDD schemes was restructured for implementation from 2021-22 to 2025-26 focusing on initiatives for improving quality, strengthening/creation of infrastructure for milk collection, chilling, processing, value addition and testing. NPDD scheme has two components:-

Component 'A' focuses towards creating/strengthening of infrastructure for quality milk testing equipment as well as primary chilling facilities.

Component 'B' (Dairying through Cooperatives) aims to increase sales of milk and dairy products, upgrading dairy processing facilities and marketing infrastructure and enhancing the capacity of producer-owned institutions.

Under NPDD scheme financial assistance is provided primarily for installation of bulk milk coolers at village level, strengthening of milk testing facilities at village and dairy plant level, certification & accreditation of dairy establishments, strengthening milk procurement, processing & marketing infrastructure etc. This ensures that the quality of milk and milk products is enhanced and that the share of organized procurement and processing of milk is increased.
