Will the Minister of COMMERCE & INDUSTRY (वाणिज्य एवं उद्योग मंत्री) be pleased to state:

(a) whether the Directorate General of Foreign Trade (DGFT) is collaborating with the various e-commerce companies to leverage the Districts as Export Hubs initiative and promote e-commerce export from the country;

(b) if so, the details thereof;

(c) the aims and objectives of establishing Districts as Export Hubs;

(d) whether the Government has signed any Memorandum of Understanding (MoU) with private players in this regard and if so, the details thereof; and

(e) whether the Government has identified the districts for capacity building and hand holding sessions under the MoU and if so, the details thereof, district-wise?

THE MINISTER OF STATE IN THE MINISTRY OF COMMERCE AND INDUSTRY (SMT. ANUPRIYA PATEL)

(a) to (c) The Foreign Trade Policy (FTP), 2023 aims to promote E-Commerce exports by bringing exporters under the ambit of various export promotion schemes of the Government. In line with the special emphasis laid in the FTP 2023 on e-commerce exports and leveraging the institutional mechanism created in the Districts under Districts as Export Hubs, the outreach events are being held in the districts under Districts as Export Hubs initiative with focus on promoting e-commerce exports

of the identified goods from the districts in collaboration with various stakeholders including the ecommerce platforms, various concerned central and state government departments such as the Department of Posts, Central Board of Indirect Taxes and Customs (CBIC), Banks, Ministry of Micro, Small and Medium Enterprises (MSME), Export Promotion Councils, Local Trade Associations/Chambers of Commerce, District Industries Centers, etc. The aim of these programs under the Districts as Export hubs initiative is to enable exporters/MSMEs to sell their 'Made in India' products to customers internationally, leveraging various global platforms available in other countries.

(d) & (e) To take forward the mandate under the Foreign Trade policy 2023, Directorate General of Foreign Trade (DGFT) is collaborating with the various e-commerce platforms to promote ecommerce export from the country. The core objective of this collaboration is to leverage e-commerce platforms operating in other countries to support local exporters, manufacturers, and MSMEs in India in reaching potential international buyers. Under the collaboration, Districts will be identified by various e-commerce platforms operating outside India, to undertake various capacity-building and outreach activities in collaboration with DGFT- Regional Authorities. These activities will focus on educating MSMEs on e-commerce exports and enabling them to resolve their doubts and issues in selling to customers across the world. In addition, the capacity building session will allow MSMEs to learn about imaging, digital cataloguing of their products. DGFT is under discussion with various e-commerce platforms to work in the districts to conduct these capacity building training sessions in programs organized by DGFT Regional Authorities. As part of that collaboration with various ecommerce platforms, the first MOU has been signed by DGFT with Amazon India for collaborating in 20 districts, on pilot basis (Annexure), while the discussion with other e-commerce platforms operating in other countries for conducting these training sessions in other districts is ongoing.
