MODERNIZATION OF AIR AND DD KENDRAS

293. ADV. A.M. ARIFF:

Will the Minister of INFORMATION AND BROADCASTING be pleased to state:

- (a) whether the Government has taken any measures for the modernization of Akashvani and Doordarshan Kendras in the country including those from Kerala to meet the changing demands and if so, the details thereof;
- (b) whether it is true that several All India Radio (AIR) stations are still functioning with old vacuum tube transformers which result in consumption of more power and resulting in higher operational costs, if so, the details thereof including along with the list of such AIR stations, State and UT-wise;
- (c) whether the Government proposes to replace the old vacuum tube transformers by Digital Radio Mondiale (DRM) transmitters to ensure smooth functioning and reduce operational costs in a time bound manner;

- (d) if so, the details thereof and if not, the reasons therefor; and
- (e) the details of the amounts sanctioned, released and utilized for each of the AIR stations in Kerala in Financial Year 2023-24 as on date?

ANSWER

THE MINISTER OF INFORMATION AND BROADCASTING; AND MINISTER OF YOUTH AFFAIRS AND SPORTS (SHRI ANURAG SINGH THAKUR)

(a) to (d): The modernization and strengthening of infrastructure and network of Prasar Bharati in respect of Akashvani and Doordarshan (DD) at different stations across the country is a continuous process under the "Broadcasting Infrastructure and Network Development" (BIND) Scheme. This scheme has been further continued for the period 2021-26 with an outlay of Rs. 2539.61 crores for various components.

Presently, only 25 Akashvani stations are functioning with vacuum tube transmitters. State/UT- wise details are at Annexure-I.

(e): The details of funds sanctioned, released and utilised for each of the AIR stations in Kerala are at Annexure -II.
