- (c) whether it is a fact that Odisha, Maharashtra and Tamil Nadu are the hub of highest handloom weavers in the country and if so, the initiatives undertaken by the Government to support handloom and textile weavers of these States;
- (d) whether the Government plans to develop more such hubs in different parts of the country, if so, the details thereof and if not, the reasons therefor; and
- (e) the steps taken by the Government to provide an export oriented boost to the textile sector especially within the States of Odisha, Maharashtra and Tamil Nadu?

(c): As per fourth Handloom Census-2019-20, total handloom workers across the country is 35,22,512, including 1,17,836 (in Odisha), 3,509 (in Maharashtra) and 2,43,575 (in Tamil Nadu). Ministry of Textiles is implementing the following schemes to promote handlooms and welfare of handloom weavers across the country:

- 1. National Handloom Development Programme;
- 2. Raw Material Supply Scheme;

Under the above schemes, financial assistance is provided to eligible handloom agencies/weavers for raw materials, procurement of upgraded looms & accessories, solar lighting units, construction of workshed, training and skill upgradation under SAMARTH, product & design development, technical and common infrastructure, marketing support for handloom products in domestic/overseas markets, concessional loans under weavers' MUDRA scheme and social security etc.

Besides the above, Government has taken following initiatives to promote the handloom industry including Odisha, Maharashtra and Tamil Nadu:

- i) To enhance productivity, marketing capabilities and ensure better incomes, 155 Handloom Producer companies have been formed across country in handloom sectors including 9 (in Odisha), 7 (in Maharashtra) and 14 (in Tamilnadu).
- ii) To integrate Craft promotion with tourism, Craft Handloom Villages are being set up across the country.
- iii) 16 Design Resource Centres have been set up in Weavers' Service Centres across the country including Bhubneswar (in Odisha), Mumbai & Nagpur (in Maharastra) and Kancheepuram & Chennai (in Tamil Nadu).
- iv) Handloom weavers are on-boarded on Government e-Market place to enable them to sell their products directly to various Government Departments and organizations.

- (d): Under the PM Mega Integrated Textile Region and Apparel (PM MITRA) Scheme, the Government has approved setting up of 7 Mega Parks in Greenfield/Brownfield sites with world class infrastructure including plug and play facility with an outlay of Rs. 4,445 crores. 7 sites viz. Tamil Nadu (Virudhnagar), Telangana (Warangal), Gujarat (Navsari), Karnataka (Kalaburagi), Madhya Pradesh (Dhar), Uttar Pradesh (Lucknow) and Maharashtra (Amravati) have been approved for setting up textile parks under PM MITRA Scheme. It is envisaged that one lakh direct and two lakh indirect employment will be generated from each such Mega Textile Park.
- (e): Government is implementing a number of schemes to strengthen the Textile Value Chain across the country including construction and promotion of textile hubs. These include PM Mega Integrated Textile Region and Apparel (PM MITRA) Parks, Scheme for Integrated Textile Parks, Integrated Processing Development Scheme, Comprehensive Powerloom Mega Cluster Development Scheme, SAMARTH (Scheme for Capacity Building in Textile Sector), Silk Samagra, National Handloom Development Programme, National Handicraft Development Programme, Integrated Wool Development Programme, National Technical Textile Mission, Production Linked Incentive scheme, etc.
