Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) the details and number of registered MSMEs being run by women entrepreneurs in the country along with the loans disbursed under the various schemes to women-led MSMEs in the country, State/ UT-wise, especially in Gujarat;
- (b) the details of loan applications pending with the Government to support women enterprises of West Bengal during the last three years along with total number of applications received, disbursement and repayment made therein; and
- (c) whether the Government proposes to clear all such applications under MSMEs by March 2024 and if so, the details thereof?

(a) to (c): The State/UTs –wise details of women-owned Micro, Small and Medium Enterprises (MSMEs) registered on Udyam Portal in the country, including the State of Gujarat are attached at **Annexure I**. The State/UTs-wise details of assistance extended under Credit Guarantee Scheme for Micro and Small Enterprises and Prime Minister’s Employment Generation Programme (PMEGP) to women-owned MSMEs, in the country, including the States of Gujarat and West Bengal are attached at **Annexure II** and **Annexure III**, respectively. As reported by Reserve Bank of India (RBI) that data pertaining to loan disbursement to women led MSMEs is not maintained.
