- (a) whether the Government has taken steps to establish institutes for training and skill development in the aviation sector and if so, the details thereof;
- (b) the number of students trained in the aviation sector in the Government institutes during the last three years;
- (c) whether the Government has taken steps for capacity building/training for firefighting at Airports; and
- (d) if so, the details of the institutes and courses thereof:?

ANSWER

Minister of State in the Ministry of CIVIL AVIATION (GEN. (DR) V. K. SINGH (RETD))

- (a) The initiatives taken by the Government for training and skill development in the aviation sector include the following:
- (i) AAI in-association with National Skill Development Centre (NSDC)
- & Aerospace & Aviation Sector Skill Council (AASSC) has set up Aviation Skill Centres at Chandigarh and Mumbai to augment the availability of Skilled Manpower in Aviation Sector and has identified following job roles for imparting the training:
- 1) Airline Customer Service Executive
- 2) Airline Reservation Agent
- 3) Airline Cargo Assistant
- 4) Airline Ramp executive

- 5) Airline Flight Load Controller
- **6)Airline Security Executive**
- 7) Airport X Ray qualified Staff
- 8) Airport Facility Services
- 9) Airline Baggage Handler;;

- (ii) In order to augment the supply of trained pilots in the country, the Airports Authority of India (AAI) has brought out a liberalised Flying Training Organisation (FTO) policy whereby the concept of airport royalty (revenue share payment by FTOs to AAI) has been abolished and land rentals have been significantly rationalised.
- (iii) In 2021, after a competitive bidding process, AAI awarded nine FTO slots at five airports at Belagavi (Karnataka), Jalgaon (Maharashtra), Kalaburagi (Karnataka), Khajuraho (Madhya Pradesh) and Lilabari (Assam). In June 2022, under second round of bidding, six FTO slots were awarded by AAI at five airports namely: two slots at Bhavnagar (Gujarat), and one each at Hubballi (Karnataka), Kadappa (Andhra Pradesh), Kishangarh (Rajasthan) and Salem (Tamil Nadu).;

Currently, there are 34 Flying Training Organisations (FTOs) in the country operating at 55 bases which are imparting flying training to cadets

- (iv) The DGCA approves Drone Training Schools as per the Drone Rules 2021. Under these Rules, currently, 76 drone training schools have been approved for providing drone training/skilling across the country.;
- (v) There are 03 Air Traffic Services Training Organizations (ATSTO).;
- (vi) There are 08 Aviation English Language Training Organizations (AELTO) for ATCOs.;
- (vii) A total of 56 Aircraft Maintenance Engineering (AME) Training Institutes have been approved by DGCA under Civil Aviation Requirements (CAR)-147 (Basic) to impart basic maintenance training.;
