Will the Minister of ROAD TRANSPORT AND HIGHWAYS

be pleased to state:

(a) the reasons for delay in completion of National Highways (NH)-53 and NH-55;

(b) whether the delay is on the part of the contractor or lack of fund or any other administrative reasons and if so, the details thereof;

(c) the time by which the said highways are likely to be completed;

(d) the likely cost escalation due to the delay; and

(e) the steps taken to control pollution in the area arising out of the NH work?

ANSWER

THE MINISTER OF ROAD TRANSPORT AND HIGHWAYS (SHRI NITIN JAIRAM GADKARI)

(a) & (b) Improvement and upgradation of highways is a continuous process. At present there are 17 number of ongoing works on NH-53 and NH-55, out of which 12 number of works have been delayed.

The delays are attributable to various reasons such as delay in land acquisition, forest clearence, utility shifting & tree felling permission, slow progress by the contractor/sub-contractor, disruption in mining activities, delay in clearance from Railways in respect of fabrication and launching of girders for ROBs/RUBs, COVID Pandemic, etc.

(c) The revise schedule completion of NH-53 & NH-55 is as given in Annexure.

(d) There is a provision of price adjustment in the contract /concession agreements for NH works. In the extended period, price adjustment is paid to contractor/concessionaire if delay is on account of Authority's Default(s)/Force Majeure Event(s) and no other cost escalation is permitted.

(e) For each NH improvement and upgradation project, environment plan is prepared in advance and accordingly various steps are taken by the contractor/concessionaire to prevent air/water pollution.
