EXPANSION OF INTERNATIONAL AIRLINE SERVICE

3110. SHRIMATI POONAM MAHAJAN Will the Minister of CIVIL AVIATION

be pleased to state:-

- (a) whether it is a fact that India is expected to overtake China and United States as the third-largest air passenger market in the world in the next ten years or by 2030 and if so, the details thereof;
- (b) whether the Government is capable of achieving that target and if so, the details thereof;
- (c) the details of number of air passengers that India caters to during the last five years, country and year-wise;
- (d) whether it is also a fact that the Union Government proposes to expand its international airline service to new nations; and
- (e) if so, the details thereof and if not, the reasons therefor?

ANSWER

Minister of State in the Ministry of CIVIL AVIATION (GEN. (DR) V. K. SINGH (RETD))

(a) to (e): There is no mechanism to project the passenger market of India in comparison to the other countries.

The year-wise details of the Scheduled Domestic and International passengers for the last five years are mentioned in Annexure -A, and the Country-wise details of the Scheduled International passengers for the last five years is given in Annexure B.

Indian Airlines are free to select whatever markets and network they wish to service and operate within the ambit of bilateral agreements. The airlines provide air services to specific places depending upon the traffic demand and commercial viability. The start of international flights from any point in India is purely a commercial decision of the

airlines on the basis of economic viability of the route, availability of aircraft, etc.
