TEACHERS IN EKLAVYA MODEL RESIDENTIAL SCHOOLS

42. SHRI RITESH PANDEY:

Will the Minister of TRIBAL AFFAIRS be pleased to state:

(a) whether the Government is aware of the large-scale shortage of teachers and permanent staff in Eklavya Model Residential Schools across the country;

(b) the numbr of vacancies and sanctioned posts for teachers and permanent staff in EMRS, State-wise;

(c) whether the Government plans to fast-track the recruitment process and fill these vacancies and if so, the progress made so far and details about the future action plan for recruitment;

(d) whether the Government intends to reconsider the 3-year timeline for filling these posts considering its detrimental impact on the quality of education; and

(e) if so, the details thereof and if not, reasons therefor?

ANSWER

MINISTER OF STATE FOR TRIBAL AFFAIRS (SMT. RENUKA SINGH SARUTA)

(a) and (b): The Government is aware of the shortage of teachers and permanent staff in Eklavya Model Residential Schools (EMRS) across the country. The State-wise number of vacancies and sanctioned posts in respect of teaching and non-teaching staff in EMRSs is at **Annexure**.

(c) : For smooth functioning of EMRS, National Education Society for Tribal Students (NESTS), the autonomous body under the Ministry to manage and implement the scheme of EMRS, has initiated recruitment process to fill up the existing 10391 vacant positions of teaching and non-teaching staff in first phase. Advertisements for recruitment of these teaching and non-teaching staff have been published on 28th June, 2023 and 18th July, 2023. Written test for the above posts has been scheduled for December, 2023. The tentative schedule for the completion of the recruitment cycle for thefirst phase of recruitment is March, 2024.

(d) and (e): Department of Expenditure has sanctioned 38,480 posts for these EMRSs to be filled in a phased manner over next three years. The phasing of recruitment process has been designed to match the requirements of schools as and when they become functional.
